#### The Proposal

#### 1 Those who may propose an arrangement.

- (1) The directors of a company [<sup>F1</sup>(other than one which is in administration or being wound up)] may make a proposal under this Part to the company and to its creditors for a composition in satisfaction of its debts or a scheme of arrangement of its affairs (from here on referred to, in either case, as a "voluntary arrangement").
- (2) A proposal under this Part is one which provides for some person ("the nominee") to act in relation to the voluntary arrangement either as trustee or otherwise for the purpose of supervising its implementation; and the nominee must be a person who is qualified to act as an insolvency practitioner <sup>F2</sup>[<sup>F3</sup>... in relation to the voluntary arrangement].
- (3) Such a proposal may also be made—
  - $[^{F4}(a)]$  where the company is in administration, by the administrator,]
    - (b) where the company is being wound up, by the liquidator.
- [<sup>F5</sup>(4) In this Part "company" means—
  - [<sup>F6</sup>(a) a company registered under the Companies Act 2006 in England and Wales or Scotland;]
    - (b) a company incorporated in an EEA State other than the United Kingdom; or
    - (c) a company not incorporated in an EEA State but having its centre of main interests in a member State other than Denmark.

#### 2 Procedure where nominee is not the liquidator or administrator.

- (1) This section applies where the nominee under section 1 is not the liquidator or administrator of the company <sup>F9</sup>....
- (2) The nominee shall, within 28 days (or such longer period as the court may allow) after he is given notice of the proposal for a voluntary arrangement, submit a report to the court stating—
  - (a) [<sup>F10</sup>whether, in his opinion, the proposed voluntary arrangement has a reasonable prospect of being approved and implemented,]

- [<sup>F11</sup>(b) whether, in his opinion, the proposal should be considered by a meeting of the company and by the company's creditors, and
  - (c) if in his opinion it should, the date on which, and time and place at which, he proposes a meeting of the company should be held.]
- (3) For the purposes of enabling the nominee to prepare his report, the person intending to make the proposal shall submit to the nominee—
  - (a) a document setting out the terms of the proposed voluntary arrangement, and
  - (b) a statement of the company's affairs containing—
    - (i) such particulars of its creditors and of its debts and other liabilities and of its assets as may be prescribed, and
    - (ii) such other information as may be prescribed.

[<sup>F12</sup>(4) The court may—

- (a) on an application made by the person intending to make the proposal, in a case where the nominee has failed to submit the report required by this section or has died, or
- (b) on an application made by that person or the nominee, in a case where it is impracticable or inappropriate for the nominee to continue to act as such,

direct that the nominee be replaced as such by another person qualified to act as an insolvency practitioner <sup>F13</sup>... in relation to the voluntary arrangement.]

## **3** [<sup>F14</sup>Consideration of proposal].

- (1) Where the nominee under section 1 is not the liquidator or administrator, and it has been report to the court [<sup>F15</sup>under section 2(2) that the proposal should be considered by a meeting of the company and by the company's creditors], the person making the report shall (unless the court otherwise [<sup>F16</sup>directs)—
  - (a) summon a meeting of the company to consider the proposal for the time, date and place proposed in the report, and

- (b) seek a decision from the company's creditors as to whether they approve the proposal.]
- (2) Where the nominee is the liquidator or administrator, he [<sup>F17</sup>shall—
  - (a) summon a meeting of the company to consider the proposal for such time, date and place as he thinks fit, and
  - (b) seek a decision from the company's creditors as to whether they approve the proposal.]
- [<sup>F18</sup>(3) A decision of the company's creditors as to whether they approve the proposal is to be made by a qualifying decision procedure.
  - (4) Notice of the qualifying decision procedure must be given to every creditor of the company of whose claim and address the person seeking the decision is aware.]

## Consideration and implementation of proposal

## 4 Decisions of [<sup>F19</sup>the company and its creditors].

[<sup>F20</sup>(1) This section applies where, under section 3—

- (a) a meeting of the company is summoned to consider the proposed voluntary arrangement, and
- (b) the company's creditors are asked to decide whether to approve the proposed voluntary arrangement.
- (1A) The company and its creditors may approve the proposed voluntary arrangement with or without modifications.]
  - (2) The modifications may include one conferring the functions proposed to be conferred on the nominee on another person qualified to act as an insolvency practitioner <sup>F21</sup>... [<sup>F22</sup>in relation to the voluntary arrangement].

But they shall not include any modification by virtue of which the proposal ceases to be a proposal such as is mentioned in section 1.

- (3) [<sup>F23</sup>Neither the company nor its creditors may] approve any proposal or modification which affects the right of a secured creditor of the company to enforce his security, except with the concurrence of the creditor concerned.
- (4) Subject as follows, [<sup>F24</sup>neither the company nor its creditors may] approve any proposal or modification under which—
  - (a) any preferential debt of the company is to be paid otherwise than in priority to such of its debts as are not preferential debts, <sup>F25</sup>...
  - [<sup>F26</sup>(aa) any ordinary preferential debt of the company is to be paid otherwise than in priority to any secondary preferential debts that it may have,]
    - (b) a preferential creditor of the company is to be paid an amount in respect of  $[^{F27}an \text{ ordinary preferential debt}]$  that bears to that debt a smaller proportion than is borne to  $[^{F28}another \text{ ordinary}]$  preferential debt by the amount that is to be paid in respect of that other debt  $[^{F29}, ^{F30}...$
    - (c) a preferential creditor of the company is to be paid an amount in respect of a secondary preferential debt that bears to that debt a smaller proportion than is borne to another secondary preferential debt by the amount that is to be paid in respect of that other debt.][<sup>F31</sup>or
    - (d) in the case of a company which is a relevant financial institution (see section 387A), any non-preferential debt is to be paid otherwise than in accordance with the rules in section 176AZA(2) or (3).]

However,  $^{F32}$ ... such a proposal or modification [ $^{F33}$ may be approved] with the concurrence of the  $^{F34}$ ... creditor concerned.

- [<sup>F35</sup>(4A) Subject to subsection (4B), where the nominee's report under section 2(2) is submitted to the court before the end of the period of 12 weeks beginning with the day after the end of any moratorium for the company under Part A1, neither the company nor its creditors may approve any proposal or modification under which the following are to be paid otherwise than in full—
  - (a) moratorium debts (within the meaning given by section 174A);
  - (b) priority pre-moratorium debts (within the meaning given by section 174A).
  - (4B) Subsection (4A) does not prevent the approval of such a proposal or modification with the concurrence of the creditor concerned.]
    - (5) Subject as above, [<sup>F36</sup>the meeting of the company and the qualifying decision procedure] shall be conducted in accordance with the rules.

- (6) After the conclusion of [<sup>F37</sup>the company] meeting in accordance with the rules, the chairman of the meeting shall report the result of the meeting to the court, and, immediately after reporting to the court, shall give notice of the result of the meeting to such persons as may be prescribed.
- [<sup>F38</sup>(6A) After the company's creditors have decided whether to approve the proposed voluntary arrangement the person who sought the decision must—
  - (a) report the creditors' decision to the court, and
  - (b) immediately after reporting to the court, give notice of the creditors' decision to such persons as may be prescribed.]

#### 6 Challenge of decisions.

(1) Subject to this section, an application to the court may be made, by any of the persons specified below, on one or both of the following grounds, namely—

- (a) that a voluntary arrangement [<sup>F61</sup>which has effect under section 4A] unfairly prejudices the interests of a creditor, member or contributory of the company;
- (b) that there has been some material irregularity at or in relation to [<sup>F62</sup>the meeting of the company, or in relation to the relevant qualifying decision procedure].

[<sup>F63</sup>(1A) In this section—

- (a) the "relevant qualifying decision procedure" means the qualifying decision procedure in which the company's creditors decide whether to approve a voluntary arrangement;
- (b) references to a decision made in the relevant qualifying decision procedure include any other decision made in that qualifying decision procedure.]

(2) The persons who may apply under  $[^{F64}$  subsection (1)] are—

- (a) a person entitled, in accordance with the rules, to vote at [<sup>F65</sup>the meeting of the company or in the relevant qualifying decision procedure];

- (6) In a case where the court, on an application under this section with respect to any meeting [<sup>F85</sup>or relevant qualifying decision procedure]
  - (a) gives a direction under subsection (4)(b) [<sup>F86</sup>or (c)], or
  - (b) revokes or suspends an approval under subsection (4)(a) or (5),

the court may give such supplemental directions as it thinks fit and, in particular, directions with respect to things done [<sup>F87</sup>under the voluntary arrangement since it took effect].

(7) Except in pursuance of the preceding provisions of this section,

- [<sup>F88</sup>(a)] [<sup>F89</sup>a decision taken] at a [<sup>F90</sup>company] meeting summoned under section 3 is not invalidated by any irregularity at or in relation to the meeting [<sup>F91</sup>, and

## 7 Implementation of proposal.

- (1) This section applies where a voluntary arrangement [<sup>F94</sup>has effect under section 4A].
- (2) The person who is for the time being carrying out in relation to the voluntary arrangement the functions conferred—
  - [<sup>F95</sup>(a) on the nominee by virtue of the approval [<sup>F96</sup> of the voluntary arrangement by the company or its creditors (or both) pursuant to] section 3],
    - (b) by virtue of section 2(4) or 4(2) on a person other than the nominee,

shall be known as the supervisor of the voluntary arrangement.

- (3) If any of the company's creditors or any other person is dissatisfied by any act, omission or decision of the supervisor, he may apply to the court; and on the application the court may—
  - (a) confirm, reverse or modify any act or decision of the supervisor,
  - (b) give him directions, or
  - (c) make such other order as it thinks fit.
- (4) The supervisor—
  - (a) may apply to the court for directions in relation to any particular matter arising under the voluntary arrangement, and
  - (b) is included among the persons who may apply to the court for the winding up of the company or for an administration order to be made in relation to it.
- (5) The court may, whenever—
  - (a) it is expedient to appoint a person to carry out the functions of the supervisor, and
  - (b) it is inexpedient, difficult or impracticable for an appointment to be made without the assistance of the court,

make an order appointing a person who is qualified to act as an insolvency practitioner <sup>F97</sup>... [<sup>F98</sup>in relation to the voluntary arrangement], either in substitution for the existing supervisor or to fill a vacancy.

(6) The power conferred by subsection (5) is exercisable so as to increase the number of persons exercising the functions of supervisor or, where there is more than one person exercising those functions, so as to replace one or more of those persons.

- [<sup>F100</sup>(1) This section applies where the approval of a voluntary arrangement in relation to a company has taken effect under section 4A.]
  - (2) [<sup>F101</sup>If it appears to the supervisor that any past or present officer of the company has committed an offence in connection with the voluntary arrangement, the supervisor must forthwith]
    - (a) report the matter to the appropriate authority, and
    - (b) provide the appropriate authority with such information and give the authority such access to and facilities for inspecting and taking copies of documents (being information or documents in the possession or under the control of the <sup>F102</sup>... supervisor and relating to the matter in question) as the authority requires.

In this subsection, "the appropriate authority" means—

- (i) in the case of a company registered in England and Wales, the Secretary of State, and
- (ii) in the case of a company registered in Scotland, the Lord Advocate.
- (3) Where a report is made to the Secretary of State under subsection (2), he may, for the purpose of investigating the matter reported to him and such other matters relating to the affairs of the company as appear to him to require investigation, exercise any of the powers which are exercisable by inspectors appointed under section 431 or 432 of the [<sup>F103</sup>the Companies Act 1985] to investigate a company's affairs.
- (4) For the purpose of such an investigation any obligation imposed on a person by any provision of the [<sup>F104</sup>the Companies Acts] to produce documents or give information to, or otherwise to assist, inspectors so appointed is to be regarded as an obligation similarly to assist the Secretary of State in his investigation.
- (5) An answer given by a person to a question put to him in exercise of the powers conferred by subsection (3) may be used in evidence against him.
- (6) However, in criminal proceedings in which that person is charged with an offence to which this subsection applies—
  - (a) no evidence relating to the answer may be adduced, and
  - (b) no question relating to it may be asked,

by or on behalf of the prosecution, unless evidence relating to it is adduced, or a question relating to it is asked, in the proceedings by or on behalf of that person.

(7) Subsection (6) applies to any offence other than-

- (a) an offence under section 2 or 5 of the <sup>MI</sup>Perjury Act 1911 (false statements made on oath otherwise than in judicial proceedings or made otherwise than on oath), or
- (b) an offence under section 44(1) or (2) of the <sup>M2</sup>Criminal Law (Consolidation) (Scotland) Act 1995 (false statements made on oath or otherwise than on oath).
- (8) Where a prosecuting authority institutes criminal proceedings following any report under subsection (2), the <sup>F105</sup>... supervisor, and every officer and agent of the company past and present (other than the defendant or defender), shall give the authority all assistance in connection with the prosecution which he is reasonably able to give.

For this purpose—

"agent" includes any banker or solicitor of the company and any person employed by the company as auditor, whether that person is or is not an officer of the company,

"prosecuting authority" means the Director of Public Prosecutions, the Lord Advocate or the Secretary of State.

(9) The court may, on the application of the prosecuting authority, direct any person referred to in subsection (8) to comply with that subsection if he has failed to do so.]
