CHAPTER II E+W

JURISDICTION OF COURTS IN ENGLAND AND WALES

[^{F17}[^{F18}2 Jurisdiction: general. E+W

- (1) A court in England and Wales shall not make a section 1(1)(a) order with respect to a child unless—
- (a) it has jurisdiction under the Council Regulation, or
 - (b) the Council Regulation does not apply but—
 - (i) the question of making the order arises in or in connection with matrimonial proceedings [^{F19}or civil partnership proceedings] and the condition in section 2A of this Act is satisfied, or
 - (ii) the condition in section 3 of this Act is satisfied.]

[A court in England and Wales shall not have jurisdiction to make a special
^{F20}(2A) guardianship order under the Children Act 1989 unless the condition in section 3 of this Act is satisfied.

(2B) A court in England and Wales shall not have jurisdiction to make an order under section 26 of the Adoption and Children Act 2002 unless the condition in section 3 of this Act is satisfied.]

- [^{F21}(3) A court in England and Wales shall not make a section 1(1)(d) order unless—
- (a) it has jurisdiction under the Council Regulation, or
 - (b) the Council Regulation does not apply but—

- (1) The condition referred to in section 2(1) of this Act is that the ^{F24}... proceedings are proceedings in respect of the marriage [^{F25} or civil partnership] of the parents of the child concerned and—
- (a) the proceedings—
 - (i) are proceedings for divorce or nullity of marriage [^{F26}, or dissolution or annulment of a civil partnership], and
 - (ii) are continuing;
 - (b) the proceedings—
 - (i) are proceedings for judicial separation [^{F27} or legal separation of civil partners],
 - (ii) are continuing,and the jurisdiction of the court is not excluded by subsection (2) below; or

 - (b) an order under section 14(2) or 22(2) of this Act which is recorded as being made for the purpose of enabling Part I proceedings to be taken in England and Wales with respect to the child concerned.

RECOGNITION AND ENFORCEMENT

34 Power to order recovery of child. **E+W+N.I.**

- (1) Where—
 - (a) a person is required by a [^{F160}Part I order], or an order for the enforcement of a [^{F160}Part I order], to give up a child to another person (“the person concerned”), and

35 Powers to restrict removal of child from jurisdiction. **U.K.**

- (3) A court in Scotland—

- (a) at any time after the commencement of proceedings in connection with which the court would have jurisdiction to make a [^{F165}Part I order], or
- (b) in any proceedings in which it would be competent for the court to grant an interdict prohibiting the removal of a child from its jurisdiction,

may, on an application by any of the persons mentioned in subsection (4) below, grant interdict or interim interdict prohibiting the removal of the child from the United Kingdom or any part of the United Kingdom, or out of the control of the person in [^{F166}whose care] the child is.

36 Effect of orders restricting removal. U.K.

- (1) This section applies to any order made by a court in the United Kingdom prohibiting the removal of a child from the United Kingdom or from any specified part of it.
- (2) An order to which this section applies shall have effect in each part of the United Kingdom other than the part in which it was made—
 - (a) as if it had been made by the appropriate court in that other part, and
 - (b) in the case of an order which has the effect of prohibiting the child's removal to that other part, as if it had included a prohibition on his further removal to any place except one to which he could be removed consistently with the order.
- (3) The references in subsections (1) and (2) above to prohibitions on a child's removal include references to prohibitions subject to exceptions; and in a case where removal is prohibited except with the consent of the court, nothing in subsection (2) above shall be construed as affecting the identity of the court whose consent is required.
- (4) In this section "child" means a person who has not attained the age of sixteen; and this section shall cease to apply to an order relating to a child when he attains the age of sixteen.

37 Surrender of passports. U.K.

43 Application of Part I to dependent territories. **U.K.**
