PART VII

GENERAL

52 Jurisdiction of county courts.

- (1) [F1The county court] shall have jurisdiction to hear and determine any question arising under any provision to which this section applies (other than a question falling within the jurisdiction of [F2the appropriate tribunal] by virtue of section 13(1) or 31(1)).
- (2) This section applies to—

62 Short title, commencement and extent.

- (1) This Act may be cited as the Landlord and Tenant Act 1987.
- (2) This Act shall come into force on such day as the Secretary of State may by order appoint.
