Instructors to be registered or licensed

124 Exemption of police instructors from prohibition imposed by section 123.

- (1) Section 123(1) and (2) of this Act does not apply to the giving of instruction by a police instructor in pursuance of arrangements made by a chief officer of police or, under the authority of a chief officer of police, in pursuance of arrangements made by a local authority.
- [F1(1A) Section 123(1) and (2) also does not apply to the giving of instruction by a [F2NCA instructor] in pursuance of arrangements made by the Director General of the [F3National Crime Agency].

In this subsection "[F4NCA] instructor" means [F5 an NCA officer] whose duties consist of or include the giving instruction in the driving of motor cars to other [F6NCA officers].]
