Offences

34 Time limit for prosecutions. **E+W+S**

No prosecution for an offence under this Act which is punishable under section 35(2) below shall be begun after the expiry of—

- (a) three years from the commission of the offence; or
 - (b) one year from its discovery by the prosecutor,
- whichever is the earlier.

35 Punishment of offences. **E+W+S**

- (1) A person guilty of an offence under section 33(1) above shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale or to imprisonment for a term not exceeding three months or to both.
- (2) A person guilty of any other offence under this Act shall be liable—
 - (a) on conviction on indictment, to a fine or to imprisonment for a term not exceeding two years or to both;
 - (b) on summary conviction, to a fine not exceeding the relevant amount or to imprisonment for a term not exceeding six months or to both.
- (3) In subsection (2) above “the relevant amount” means—
 - (a) in the case of an offence under [^{F1}section 7 or 14] above, £20,000;
 - (b) in any other case, the statutory maximum.
- (4) If a person who is—
 - (a) licensed under section 1 of the ^{M1}Slaughterhouses Act 1974 to keep a ^{F2}. . . knacker’s yard;
 - ^{F3}(b)
 - (c) licensed under section 6 of [^{F4}the Slaughter of Animals (Scotland) Act 1980] to use any premises as a knacker’s yard,is convicted of an offence under Part II of this Act, the court may, in addition to any other punishment, cancel his licence or registration.
