Offences

35 Punishment of offences.

- [^{F1}(A1) A person guilty of an offence under section 15B(5) above shall be liable on summary conviction to a fine not exceeding level 4 on the standard scale.
- (A2) A person guilty of an offence under section 15C(2) or 15D(3) above shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.]
- (1) A person guilty of an offence under section 33(1) above shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale or to imprisonment for a term not exceeding three months or to both.
- [^{F2}(1A) A person guilty of an offence under section 33(2), in so far as it relates to section 15C(1) or 15D(2), shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.]
- (2) A person guilty of any other offence under this Act shall be liable—
- on conviction on indictment, to a fine or to imprisonment for a term not exceeding two years or to both;
 - on summary conviction, to [^{F3}a fine not exceeding the relevant amount][^{F3}a fine] or to imprisonment for a term not exceeding six months or to both.
- (3) [^{F4}In subsection (2) above “the relevant amount” means—
- in the case of an offence under [^{F5}section 7 or 14] above, £20,000;
 - in any other case, the statutory maximum.]
