#### STREET WORKS IN ENGLAND AND WALES

##### *General requirements as to execution of street works*

#### 68 Facilities to be afforded to street authority.

- (1) An undertaker executing street works shall afford the street authority reasonable facilities for ascertaining whether he is complying with his duties under this Part.
- (2) An undertaker who fails to afford the street authority such facilities commits an offence in respect of each failure and is liable on summary conviction to a fine not exceeding [<sup>F1</sup>level 4] on the standard scale.
