1991 CHAPTER 48

An Act to make provision for the [^{F1}calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

The basic principles

1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [^{F2}a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [^{F3}maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made to make those payments.

2 Welfare of children: the general principle.

Where, in any case which falls to be dealt with under this Act, the Secretary of State ^{F4}... is considering the exercise of any discretionary power conferred by this Act, he shall have regard to the welfare of any child likely to be affected by his decision.

3 Meaning of certain terms used in this Act.

- (1) A child is a “qualifying child” if—
 - (a) one of his parents is, in relation to him, [^{F2}a non-resident parent]; or
 - (b) both of his parents are, in relation to him, [^{F2}non-resident parents].

- (2) The parent of any child is [^{F2}a “non-resident parent”], in relation to him, if—
 - (a) that parent is not living in the same household with the child; and
 - (b) the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
 - (a) with whom the child has his home;
 - (b) who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
 - (c) who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
 - (a) parents;
 - (b) guardians;
 - (c) persons in whose favour residence orders under section 8 of the ^{M1}Children Act 1989 are in force;
 - (d) in Scotland, persons [^{F5}with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [^{F3}maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

4 Child support maintenance.

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the [F²non-resident parent] may apply to the Secretary of State for a [F³maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a [F³maintenance calculation] has been made in response to an application under this section the Secretary of State may, if the person with care or [F²non-resident parent] with respect to whom the [F¹calculation] was made applies to him under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the [F¹calculation];
 - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [F¹calculation].
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the Secretary of State to take steps to enforce that obligation whenever he considers it necessary to do so, the Secretary of State may act accordingly.
- (4) A person who applies to the Secretary of State under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the Secretary of State F⁶... being provided with the information which is required to enable—
 - (a) the [F²non-resident parent] to be [F⁷identified or] traced (where that is necessary);
 - (b) the amount of child support maintenance payable by the [F²non-resident parent] to be assessed; and
 - (c) that amount to be recovered from the [F²non-resident parent].
- (5) Any person who has applied to the Secretary of State under this section may at any time request him to cease acting under this section.
- (6) It shall be the duty of the Secretary of State to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).
- (7) The obligation to provide information which is imposed by subsection (4)—
 - (a) shall not apply in such circumstances as may be prescribed; and
 - (b) may, in such circumstances as may be prescribed, be waived by the Secretary of State.
- (8) The Secretary of State may by regulations make such incidental, supplemental or transitional provision as he thinks appropriate with respect to cases in which he is requested to cease to act under this section.
- (9) No application may be made under this section if there is in force with respect to the person with care and [F²non-resident parent] in question a [F³maintenance calculation] made in response to an application [F⁸treated as made] under section 6.

5 Child support maintenance: supplemental provisions.

- (1) Where—
- there is more than one person with care of a qualifying child; and
 - one or more, but not all, of them have parental responsibility for ^{F14}... the child; no application may be made for a [^{F3}maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for ^{F14}... the child.
- (2) Where more than one application for a [^{F3}maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.
- (3) The Secretary of State may by regulations make provision as to which of two or more applications for a [^{F3}maintenance calculation] with respect to the same child is to be proceeded with.

7 **Right of child in Scotland to apply for [F¹ calculation].**

- (1) A qualifying child who has attained the age of 12 years and who is habitually resident in Scotland may apply to the Secretary of State for a [F³ maintenance calculation] to be made with respect to him if—
 - (a) no such application has been made by a person who is, with respect to that child, a person with care or [F² a non-resident parent]; ^{F16} ...
 - ^{F16}(b)
- (2) An application made under subsection (1) shall authorise the Secretary of State to make a [F³ maintenance calculation] with respect to any other children of the [F² non-resident parent] who are qualifying children in the care of the same person as the child making the application.
- (3) Where a [F³ maintenance calculation] has been made in response to an application under this section the Secretary of State may, if the person with care, the [F² non-resident parent] with respect to whom the [F¹ calculation] was made or the child concerned applies to him under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the [F¹ calculation];
 - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [F¹ calculation].
- (4) Where an application under subsection (3) for the enforcement of the obligation mentioned in subsection (3)(b) authorises the Secretary of State to take steps to enforce that obligation whenever he considers it necessary to do so, the Secretary of State may act accordingly.

8 Role of the courts with respect to maintenance for children.

- (1) This subsection applies in any case where [^{F23}the Secretary of State] would have jurisdiction to make a [^{F3}maintenance calculation] with respect to a qualifying child and [^{F2}a non-resident parent] of his on an application duly made [^{F24}(or treated as made)] by a person entitled to apply for such [^{F1}a calculation] with respect to that child.
- (2) Subsection (1) applies even though the circumstances of the case are such that [^{F23}the Secretary of State] would not make [^{F1}a calculation] if it were applied for.
- (3) [^{F25}Except as provided in subsection (3A),] in any case where subsection (1) applies, no court shall exercise any power which it would otherwise have to make, vary or revive any maintenance order in relation to the child and [^{F2}non-resident parent] concerned.
- [^{F26}(3A) Unless a maintenance calculation has been made with respect to the child concerned, subsection (3) does not prevent a court from varying a maintenance order in relation to that child and the non-resident parent concerned—

9 Agreements about maintenance.

- (1) In this section “maintenance agreement” means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.

10 Relationship between maintenance [^{F1}calculations] and certain court orders and related matters.

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [^{F3}maintenance calculation] is made, the order—
- shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.

 - (c) the results of the tests do not exclude the alleged parent from being one of the child's parents; and
 - (d) one of the conditions set out in subsection (2) is satisfied.
- (2) The conditions are that—
- (a) the alleged parent does not deny that he is one of the child's parents;
 - (b) in proceedings under [^{F104} section 55A of the Family Law Act 1986], a court has made a declaration that the alleged parent is a parent of the child in question; or
 - (c) in an action under section 7 of the Law Reform (Parent and Child) (Scotland) Act 1986, brought by the Secretary of State by virtue of section 28, a court has granted a decree of declarator of parentage to the effect that the alleged parent is a parent of the child in question.
- (3) In any case to which this section applies, any fee paid by the Secretary of State in connection with scientific tests may be recovered by him from the alleged parent as a debt due to the Crown.

31 Deduction from earnings orders.

- (1) This section applies where any person (“the liable person”) is liable to make payments of child support maintenance.
- (2) The Secretary of State may make an order (“a deduction from earnings order”) against a liable person to secure the payment of any amount due under the [^{F3}maintenance calculation] in question.

- (3) If, but only if, the court is of the opinion that there has been wilful refusal or culpable neglect on the part of the liable person it may—
- (a) issue a warrant of commitment against him; or

PART I

THE CASES

General

- 1 (1) The cases in which a variation may be agreed are those set out in this Part of this Schedule or in regulations made under this Part.
