An Act to make provision for the [^{F1}calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

The basic principles

1 The duty to maintain. **E+W+S**

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [^{F2}a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [^{F3}maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made to make those payments.

2 Welfare of children: the general principle. **E+W+S**

Where, in any case which falls to be dealt with under this Act, the [^{F4}Commission]^{F5}... is considering the exercise of any discretionary power conferred by this Act, [^{F6}it] shall have regard to the welfare of any child likely to be affected by [^{F7}its] decision.

3 Meaning of certain terms used in this Act. E+W+S

- (1) A child is a “qualifying child” if—
 - (a) one of his parents is, in relation to him, [^{F2}a non-resident parent]; or
 - (b) both of his parents are, in relation to him, [^{F2}non-resident parents].
- (2) The parent of any child is [^{F2}a “non-resident parent”], in relation to him, if—
 - (a) that parent is not living in the same household with the child; and
 - (b) the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
 - (a) with whom the child has his home;
 - (b) who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
 - (c) who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
 - (a) parents;
 - (b) guardians;
 - (c) persons in whose favour residence orders under section 8 of the ^{M1}Children Act 1989 are in force;
 - (d) in Scotland, persons [^{F8}with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [^{F3}maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

4 Child support maintenance. **E+W+S**

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the ^{F2}non-resident parent] may apply to the ^{F9}Commission] for a ^{F3}maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a ^{F3}maintenance calculation] has been made in response to an application under this section the ^{F10}Commission] may, if the person with care or ^{F2}non-resident parent] with respect to whom the ^{F1}calculation] was made applies to ^{F11}it] under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the ^{F1}calculation];
 - (b) the enforcement of the obligation to pay child support maintenance in accordance with the ^{F1}calculation].
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the ^{F12}Commission] to take steps to enforce that obligation whenever ^{F13}it] considers it necessary to do so, the ^{F12}Commission] may act accordingly.
- (4) A person who applies to the ^{F14}Commission] under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the ^{F14}Commission]^{F15}... being provided with the information which is required to enable—
 - (a) the ^{F2}non-resident parent] to be ^{F16}identified or] traced (where that is necessary);
 - (b) the amount of child support maintenance payable by the ^{F2}non-resident parent] to be assessed; and
 - (c) that amount to be recovered from the ^{F2}non-resident parent].
- (5) Any person who has applied to the ^{F17}Commission] under this section may at any time request ^{F18}it] to cease acting under this section.
- (6) It shall be the duty of the ^{F19}Commission] to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).

5 Child support maintenance: supplemental provisions. **E+W+S**

- (1) Where—
- there is more than one person with care of a qualifying child; and
 - one or more, but not all, of them have parental responsibility for ^{F28}... the child;
- no application may be made for a [^{F3}maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for ^{F28}... the child.
- (2) Where more than one application for a [^{F3}maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.

7 Right of child in Scotland to apply for [F¹ calculation]. S

- (1) A qualifying child who has attained the age of 12 years and who is habitually resident in Scotland may apply to the [F³⁰ Commission] for a [F³ maintenance calculation] to be made with respect to him if—
- (a) no such application has been made by a person who is, with respect to that child, a person with care or [F² a non-resident parent]; F³¹...

- (2) An application made under subsection (1) shall authorise the [F³² Commission] to make a [F³ maintenance calculation] with respect to any other children of the [F² non-resident parent] who are qualifying children in the care of the same person as the child making the application.

8 Role of the courts with respect to maintenance for children. **E+W+S**

- (1) This subsection applies in any case where [^{F47}the [^{F48}Commission]] would have jurisdiction to make a [^{F3}maintenance calculation] with respect to a qualifying child and [^{F2}a non-resident parent] of his on an application duly made ^{F49}... by a person entitled to apply for such [^{F1}a calculation] with respect to that child.

9 Agreements about maintenance. **E+W+S**

- (1) In this section “maintenance agreement” means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.

10 Relationship between maintenance [^{F1}calculations] and certain court orders and related matters. **E+W+S**

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [^{F3}maintenance calculation] is made, the order—
- (a) shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (2) Where an agreement of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [^{F3}maintenance calculation] is made, the agreement—
- (a) shall, so far as it relates to the making or securing of periodical payments, be unenforceable to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (3) Any regulations under this section may, in particular, make such provision with respect to—
- (a) any case where any person with respect to whom an order or agreement of a kind prescribed for the purposes of subsection (1) or (2) has effect applies to the prescribed court, before the end of the prescribed period, for the order or agreement to be varied in the light of the [^{F3}maintenance calculation] and of the provisions of this Act;
 - (b) the recovery of any arrears under the order or agreement which fell due before the coming into force of the [^{F3}maintenance calculation],
- as the Secretary of State considers appropriate and may provide that, in prescribed circumstances, an application to any court which is made with respect to an order of a prescribed kind relating to the making or securing of periodical payments to or for the benefit of a child shall be treated by the court as an application for the order to be revoked.
- (4) The Secretary of State may by regulations make provision for—

31 Deduction from earnings orders. **E+W+S**

- (1) This section applies where any person (“the liable person”) is liable to make payments of child support maintenance.
- (2) The [^{F271}Commission] may make an order (“a deduction from earnings order”) against a liable person to secure the payment of any amount due under the [^{F3}maintenance calculation] in question.
- (3) A deduction from earnings order may be made so as to secure the payment of—
 - (a) arrears of child support maintenance payable under the [^{F1}calculation];
 - (b) amounts of child support maintenance which will become due under the [^{F1}calculation]; or
 - (c) both such arrears and such future amounts.

33 Liability orders. **E+W+S**

35 Enforcement of liability orders by distress. E+W

- (1) Where a liability order has been made against a person (“the liable person”), the [^{F282}Commission] may levy the appropriate amount by distress and sale of the liable person’s goods.
- (2) In subsection (1), “the appropriate amount” means the aggregate of—

- (5) No person levying a distress under this section shall be taken to be a trespasser—

 - (b) from the beginning, on account of any subsequent irregularity in levying the distress.
- (6) A person sustaining special damage by reason of any irregularity in levying a distress under this section may recover full satisfaction for the damage (and no more) by proceedings in trespass or otherwise.
- (7) The Secretary of State may make regulations supplementing the provisions of this section.

- (a) provide that a distress under this section may be levied anywhere in England and Wales;
 - (b) provide that such a distress shall not be deemed unlawful on account of any defect or want of form in the liability order;

- (1) For the purposes of this Act a person is a child if—
 - (a) he is under the age of 16;

57 Application to Crown. **E+W+S**

- (1) The power of the Secretary of State to make regulations under section 14 requiring prescribed persons to furnish information may be exercised so as to require information to be furnished by persons employed in the service of the Crown or otherwise in the discharge of Crown functions.

- (1) This Act may be cited as the Child Support Act 1991.
- (2) Section 56(1) and subsections (1) to (11) and (14) of this section shall come into force on the passing of this Act but otherwise this Act shall come into force on such date as may be appointed by order made by the Lord Chancellor, the Secretary of State or Lord Advocate, or by any of them acting jointly.
- (3) Different dates may be appointed for different provisions of this Act and for different purposes (including, in particular, for different cases or categories of case).
- (4) An order under subsection (2) may make such supplemental, incidental or transitional provision as appears to the person making the order to be necessary or expedient in connection with the provisions brought into force by the order, including such adaptations or modifications of—
 - (a) the provisions so brought into force;

 - (c) any provision of any other enactment,as appear to him to be necessary or expedient.
- (5) Different provision may be made by virtue of subsection (4) with respect to different periods.
- (6) Any provision made by virtue of subsection (4) may, in particular, include provision for—
 - (a) the enforcement of a [^{F3} maintenance calculation] (including the collection of sums payable under the [^{F1} calculation]) as if the [^{F1} calculation] were a court order of a prescribed kind;
 - (b) the registration of maintenance [^{F1} calculations] with the appropriate court in connection with any provision of a kind mentioned in paragraph (a);
 - (c) the variation, on application made to a court, of the provisions of a [^{F3} maintenance calculation] relating to the method of making payments fixed by the [^{F1} calculation] or the intervals at which such payments are to be made;
 - (d) a [^{F3} maintenance calculation], or an order of a prescribed kind relating to one or more children, to be deemed, in prescribed circumstances, to have been validly made for all purposes or for such purposes as may be prescribed.

In paragraph (c) “court” includes a single justice.

- (7) The Lord Chancellor, the Secretary of State or the Lord Advocate may by order make such amendments or repeals in, or such modifications of, such enactments as may be specified in the order, as appear to him to be necessary or expedient in consequence of any provision made by or under this Act (including any provision made by virtue of subsection (4)).
- (8) This Act shall, in its application to the Isles of Scilly, have effect subject to such exceptions, adaptations and modifications as the Secretary of State may by order prescribe.

General rule

- 1 (1) The weekly rate of child support maintenance is the basic rate unless a reduced rate, a flat rate or the nil rate applies.
- (2) Unless the nil rate applies, the amount payable weekly to a person with care is—
 - (a) the applicable rate, if paragraph 6 does not apply; or
 - (b) if paragraph 6 does apply, that rate as apportioned between the persons with care in accordance with paragraph 6,as adjusted, in either case, by applying the rules about shared care in paragraph 7 or 8.

Basic rate

- 2 (1) The basic rate is the following percentage of the non-resident parent's net weekly income—
 - 15% where he has one qualifying child;
 - 20% where he has two qualifying children;
 - 25% where he has three or more qualifying children.
- (2) If the non-resident parent also has one or more relevant other children, the appropriate percentage referred to in sub-paragraph (1) is to be applied instead to his net weekly income less—

Reduced rate

- 3 (1) A reduced rate is payable if—
- (a) neither a flat rate nor the nil rate applies; and
 - (b) the non-resident parent’s net weekly income is less than £200 but more than £100.
- (2) The reduced rate payable shall be prescribed in, or determined in accordance with, regulations.
- (3) The regulations may not prescribe, or result in, a rate of less than £5.

Flat rate

- 4 (1) Except in a case falling within sub-paragraph (2), a flat rate of £5 is payable if the nil rate does not apply and—
- (a) the non-resident parent’s net weekly income is £100 or less; or
 - (b) he receives any benefit, pension or allowance prescribed for the purposes of this paragraph of this sub-paragraph; or
 - (c) he or his partner (if any) receives any benefit prescribed for the purposes of this paragraph of this sub-paragraph.
- (2) A flat rate of a prescribed amount is payable if the nil rate does not apply and—
- (a) the non-resident parent has a partner who is also a non-resident parent;
 - (b) the partner is a person with respect to whom a maintenance calculation is in force; and
 - (c) the non-resident parent or his partner receives any benefit prescribed under sub-paragraph (1)(c).
- (3) The benefits, pensions and allowances which may be prescribed for the purposes of sub-paragraph (1)(b) include ones paid to the non-resident parent under the law of a place outside the United Kingdom.

Nil rate

- 5 The rate payable is nil if the non-resident parent—
- (a) is of a prescribed description; or
 - (b) has a net weekly income of below £5.

Apportionment

- 6 (1) If the non-resident parent has more than one qualifying child and in relation to them there is more than one person with care, the amount of child support maintenance payable is (subject to paragraph 7 or 8) to be determined by apportioning the rate between the persons with care.

Shared care—basic and reduced rate

- 7 (1) This paragraph applies only if the rate of child support maintenance payable is the basic rate or a reduced rate.
- (2) If the care of a qualifying child is shared between the non-resident parent and the person with care, so that the non-resident parent from time to time has care of the child overnight, the amount of child support maintenance which he would otherwise have been liable to pay the person with care, as calculated in accordance with the preceding paragraphs of this Part of this Schedule, is to be decreased in accordance with this paragraph.
- (3) First, there is to be a decrease according to the number of such nights which the [F395Commission] determines there to have been, or expects there to be, or both during a prescribed twelve-month period.
- (4) The amount of that decrease for one child is set out in the following Table—

Number of nights	Fraction to subtract
52 to 103	One-seventh
104 to 155	Two-sevenths
156 to 174	Three-sevenths
175 or more	One-half

- (5) If the person with care is caring for more than one qualifying child of the non-resident parent, the applicable decrease is the sum of the appropriate fractions in the Table divided by the number of such qualifying children.
- (6) If the applicable fraction is one-half in relation to any qualifying child in the care of the person with care, the total amount payable to the person with care is then to be further decreased by £7 for each such child.
