1991 CHAPTER 48

An Act to make provision for the [^{F1}calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

The basic principles

1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [^{F2}a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [^{F3}maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made to make those payments.

2 Welfare of children: the general principle.

Where, in any case which falls to be dealt with under this Act, the [^{F4}Commission]^{F5}... is considering the exercise of any discretionary power conferred by this Act, [^{F6}it] shall have regard to the welfare of any child likely to be affected by [^{F7}its] decision.

3 Meaning of certain terms used in this Act.

- (1) A child is a “qualifying child” if—
 - (a) one of his parents is, in relation to him, [^{F2}a non-resident parent]; or
 - (b) both of his parents are, in relation to him, [^{F2}non-resident parents].
- (2) The parent of any child is [^{F2}a “non-resident parent”], in relation to him, if—
 - (a) that parent is not living in the same household with the child; and
 - (b) the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
 - (a) with whom the child has his home;
 - (b) who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
 - (c) who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
 - (a) parents;
 - (b) guardians;
 - (c) persons in whose favour residence orders under section 8 of the ^{M1}Children Act 1989 are in force;
 - (d) in Scotland, persons [^{F8}with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [^{F3}maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

4 Child support maintenance.

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the [F²non-resident parent] may apply to the [F⁹Commission] for a [F³maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a [F³maintenance calculation] has been made in response to an application under this section the [F¹⁰Commission] may, if the person with care or [F²non-resident parent] with respect to whom the [F¹calculation] was made applies to [F¹¹it] under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the [F¹calculation];
 - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [F¹calculation].
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the [F¹²Commission] to take steps to enforce that obligation whenever [F¹³it] considers it necessary to do so, the [F¹²Commission] may act accordingly.
- (4) A person who applies to the [F¹⁴Commission] under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the [F¹⁴Commission]^{F¹⁵}... being provided with the information which is required to enable—
 - (a) the [F²non-resident parent] to be [F¹⁶identified or] traced (where that is necessary);
 - (b) the amount of child support maintenance payable by the [F²non-resident parent] to be assessed; and
 - (c) that amount to be recovered from the [F²non-resident parent].
- (5) Any person who has applied to the [F¹⁷Commission] under this section may at any time request [F¹⁸it] to cease acting under this section.
- (6) It shall be the duty of the [F¹⁹Commission] to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).
- (7) The obligation to provide information which is imposed by subsection (4)—
 - (a) shall not apply in such circumstances as may be prescribed; and
 - (b) may, in such circumstances as may be prescribed, be waived by the [F²⁰Commission].

5 Child support maintenance: supplemental provisions.

- (1) Where—
- there is more than one person with care of a qualifying child; and
 - one or more, but not all, of them have parental responsibility for ^{F28}... the child; no application may be made for a [^{F3}maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for ^{F28}... the child.
- (2) Where more than one application for a [^{F3}maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.
- (3) The Secretary of State may by regulations make provision as to which of two or more applications for a [^{F3}maintenance calculation] with respect to the same child is to be proceeded with.

7 Right of child in Scotland to apply for [^{F1}calculation].

- (1) A qualifying child who has attained the age of 12 years and who is habitually resident in Scotland may apply to the [^{F30}Commission] for a [^{F3}maintenance calculation] to be made with respect to him if—
 - (a) no such application has been made by a person who is, with respect to that child, a person with care or [^{F2}a non-resident parent]; ^{F31}...
 - ^{F31}(b)
- (2) An application made under subsection (1) shall authorise the [^{F32}Commission] to make a [^{F3}maintenance calculation] with respect to any other children of the [^{F2}non-resident parent] who are qualifying children in the care of the same person as the child making the application.
- (3) Where a [^{F3}maintenance calculation] has been made in response to an application under this section the [^{F33}Commission] may, if the person with care, the [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made or the child concerned applies to [^{F34}it] under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the [^{F1}calculation];

10 Relationship between maintenance [^{F1}calculations] and certain court orders and related matters.

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [^{F3}maintenance calculation] is made, the order—
 - (a) shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (2) Where an agreement of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [^{F3}maintenance calculation] is made, the agreement—
 - (a) shall, so far as it relates to the making or securing of periodical payments, be unenforceable to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (3) Any regulations under this section may, in particular, make such provision with respect to—

32F Lump sum deductions: final orders

- (1) The Commission may make an order under this section in pursuance of a proposal specified in an order under section 32E if—

32G Orders under sections 32E and 32F: freezing of accounts etc.

- (1) During the relevant period, an order under section 32E or 32F which specifies an account held with a deposit-taker shall operate as an instruction to the deposit-taker not to do anything that would reduce the amount standing to the credit of the account below the amount specified in the order (or, if already below that amount, that would further reduce it).

35 Enforcement of liability orders by distress.

- (1) Where a liability order has been made against a person (“the liable person”), the [F²⁸⁸Commission] may levy the appropriate amount by distress and sale of the liable person’s goods.
- (2) In subsection (1), “the appropriate amount” means the aggregate of—
 - (a) the amount in respect of which the order was made, to the extent that it remains unpaid; and
 - (b) an amount, determined in such manner as may be prescribed, in respect of the charges connected with the distress.
- (3) The [F²⁸⁹Commission] may, in exercising [F²⁹⁰its] powers under subsection (1) against the liable person’s goods, seize—
 - (a) any of the liable person’s goods except—
 - (i) such tools, books, vehicles and other items of equipment as are necessary to him for use personally by him in his employment, business or vocation;
 - (ii) such clothing, bedding, furniture, household equipment and provisions as are necessary for satisfying his basic domestic needs; and
 - (b) any money, banknotes, bills of exchange, promissory notes, bonds, specialties or securities for money belonging to the liable person.
- (4) For the purposes of subsection (3), the liable person’s domestic needs shall be taken to include those of any member of his family with whom he resides.
- (5) No person levying a distress under this section shall be taken to be a trespasser—
 - (a) on that account; or
 - (b) from the beginning, on account of any subsequent irregularity in levying the distress.
- (6) A person sustaining special damage by reason of any irregularity in levying a distress under this section may recover full satisfaction for the damage (and no more) by proceedings in trespass or otherwise.
- (7) The Secretary of State may make regulations supplementing the provisions of this section.
- (8) The regulations may, in particular—
 - (a) provide that a distress under this section may be levied anywhere in England and Wales;
 - (b) provide that such a distress shall not be deemed unlawful on account of any defect or want of form in the liability order;
 - (c) provide for an appeal to a magistrates’ court by any person aggrieved by the levying of, or an attempt to levy, a distress under this section;
 - (d) make provision as to the powers of the court on an appeal (which may include provision as to the discharge of goods distrained or the payment of compensation in respect of goods distrained and sold).

 - (b) the partner is a person with respect to whom a maintenance calculation is in force; and
 - (c) the non-resident parent or his partner receives any benefit prescribed under sub-paragraph (1)(c).
- (3) The benefits, pensions and allowances which may be prescribed for the purposes of sub-paragraph (1)(b) include ones paid to the non-resident parent under the law of a place outside the United Kingdom.

Nil rate

- 5 The rate payable is nil if the non-resident parent—
- (a) is of a prescribed description; or
 - (b) has a net weekly income of below £5.

Apportionment

- 6 (1) If the non-resident parent has more than one qualifying child and in relation to them there is more than one person with care, the amount of child support maintenance payable is (subject to paragraph 7 or 8) to be determined by apportioning the rate between the persons with care.

52 to 103	One-seventh
104 to 155	Two-sevenths
156 to 174	Three-sevenths
175 or more	One-half

- (5) If the person with care is caring for more than one qualifying child of the non-resident parent, the applicable decrease is the sum of the appropriate fractions in the Table divided by the number of such qualifying children.
- (6) If the applicable fraction is one-half in relation to any qualifying child in the care of the person with care, the total amount payable to the person with care is then to be further decreased by £7 for each such child.
- (7) If the application of the preceding provisions of this paragraph would decrease the weekly amount of child support maintenance (or the aggregate of all such amounts) payable by the non-resident parent to the person with care (or all of them) to less than £5, he is instead liable to pay child support maintenance at the rate of £5 a week, apportioned (if appropriate) in accordance with paragraph 6.
