1991 CHAPTER 48

An Act to make provision for the [^{F1}calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

The basic principles

1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [^{F2}a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [^{F3}maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made to make those payments.

2 Welfare of children: the general principle.

Where, in any case which falls to be dealt with under this Act, the [^{F4}Commission]^{F5}... is considering the exercise of any discretionary power conferred by this Act, [^{F6}it] shall have regard to the welfare of any child likely to be affected by [^{F7}its] decision.

3 Meaning of certain terms used in this Act.

- (1) A child is a “qualifying child” if—
- one of his parents is, in relation to him, [^{F2}a non-resident parent]; or
 - both of his parents are, in relation to him, [^{F2}non-resident parents].
- (2) The parent of any child is [^{F2}a “non-resident parent”], in relation to him, if—
- that parent is not living in the same household with the child; and
 - the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
- with whom the child has his home;
 - who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
 - who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
- parents;
 - guardians;
 - persons in whose favour residence orders under section 8 of the ^{M1}Children Act 1989 are in force;
 - in Scotland, persons [^{F8}with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [^{F3}maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

4 Child support maintenance.

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the ^[F2]non-resident parent] may apply to the ^[F9]Commission] for a ^[F3]maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a ^[F3]maintenance calculation] has been made in response to an application under this section the ^[F10]Commission] may, if the person with care or ^[F2]non-resident parent] with respect to whom the ^[F1]calculation] was made applies to ^[F11]it] under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the ^[F1]calculation];
 - (b) the enforcement of the obligation to pay child support maintenance in accordance with the ^[F1]calculation].
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the ^[F12]Commission] to take steps to enforce that obligation whenever ^[F13]it] considers it necessary to do so, the ^[F12]Commission] may act accordingly.
- (4) A person who applies to the ^[F14]Commission] under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the ^[F14]Commission]^{F15} ... being provided with the information which is required to enable—
 - (a) the ^[F2]non-resident parent] to be ^[F16]identified or] traced (where that is necessary);
 - (b) the amount of child support maintenance payable by the ^[F2]non-resident parent] to be assessed; and
 - (c) that amount to be recovered from the ^[F2]non-resident parent].
- (5) Any person who has applied to the ^[F17]Commission] under this section may at any time request ^[F18]it] to cease acting under this section.
- (6) It shall be the duty of the ^[F19]Commission] to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).

5 Child support maintenance: supplemental provisions.

- (1) Where—
- there is more than one person with care of a qualifying child; and
 - one or more, but not all, of them have parental responsibility for ^{F28}... the child;
- no application may be made for a [^{F3}maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for ^{F28}... the child.
- (2) Where more than one application for a [^{F3}maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.

7 Right of child in Scotland to apply for [F¹ calculation].

- (1) A qualifying child who has attained the age of 12 years and who is habitually resident in Scotland may apply to the [F³⁰ Commission] for a [F³ maintenance calculation] to be made with respect to him if—
 - (a) no such application has been made by a person who is, with respect to that child, a person with care or [F² a non-resident parent]; ^{F31}...
 - ^{F31}(b)
- (2) An application made under subsection (1) shall authorise the [F³² Commission] to make a [F³ maintenance calculation] with respect to any other children of the [F² non-resident parent] who are qualifying children in the care of the same person as the child making the application.
- (3) Where a [F³ maintenance calculation] has been made in response to an application under this section the [F³³ Commission] may, if the person with care, the [F² non-resident parent] with respect to whom the [F¹ calculation] was made or the child concerned applies to [F³⁴ it] under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the [F¹ calculation];
 - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [F¹ calculation].

 - (c) that amount to be recovered from the [F2non-resident parent].
- (6) The child who has made the application (but not the person having care of him) may at any time request the [F39Commission] to cease acting under this section.
- (7) It shall be the duty of the [F40Commission] to comply with any request made under subsection (6) (but subject to any regulations made under subsection (9)).
- (8) The obligation to provide information which is imposed by subsection (5)—
- (a) shall not apply in such circumstances as may be prescribed by the Secretary of State; and
 - (b) may, in such circumstances as may be so prescribed, be waived by the [F41Commission].

8 Role of the courts with respect to maintenance for children.

- (1) This subsection applies in any case where [^{F47}the [^{F48}Commission]] would have jurisdiction to make a [^{F3}maintenance calculation] with respect to a qualifying child and [^{F2}a non-resident parent] of his on an application duly made ^{F49}... by a person entitled to apply for such [^{F1}a calculation] with respect to that child.

9 Agreements about maintenance.

- (1) In this section “maintenance agreement” means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.
- (2) Nothing in this Act shall be taken to prevent any person from entering into a maintenance agreement.

10 Relationship between maintenance [^{F1}calculations] and certain court orders and related matters.

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [^{F3}maintenance calculation] is made, the order—
- (a) shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (2) Where an agreement of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [^{F3}maintenance calculation] is made, the agreement—
- (a) shall, so far as it relates to the making or securing of periodical payments, be unenforceable to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (3) Any regulations under this section may, in particular, make such provision with respect to—
- (a) any case where any person with respect to whom an order or agreement of a kind prescribed for the purposes of subsection (1) or (2) has effect applies to the prescribed court, before the end of the prescribed period, for the order or agreement to be varied in the light of the [^{F3}maintenance calculation] and of the provisions of this Act;
 - (b) the recovery of any arrears under the order or agreement which fell due before the coming into force of the [^{F3}maintenance calculation],
- as the Secretary of State considers appropriate and may provide that, in prescribed circumstances, an application to any court which is made with respect to an order of a prescribed kind relating to the making or securing of periodical payments to or for the benefit of a child shall be treated by the court as an application for the order to be revoked.
- (4) The Secretary of State may by regulations make provision for—

31 Deduction from earnings orders.

- (1) This section applies where any person (“the liable person”) is liable to make payments of child support maintenance.
- (2) The [^{F277}Commission] may make an order (“a deduction from earnings order”) against a liable person to secure the payment of any amount due under the [^{F3}maintenance calculation] in question.
- (3) A deduction from earnings order may be made so as to secure the payment of—
 - (a) arrears of child support maintenance payable under the [^{F1}calculation];
 - (b) amounts of child support maintenance which will become due under the [^{F1}calculation]; or

- (4) A deduction from earnings order—
 - (a) shall be expressed to be directed at a person (“the employer”) who has the liable person in his employment; and
 - (b) shall have effect from such date as may be specified in the order.
- (5) A deduction from earnings order shall operate as an instruction to the employer to—
 - (a) make deductions from the liable person’s earnings; and
 - (b) pay the amounts deducted to the [^{F277}Commission].
- (6) The [^{F277}Commission] shall serve a copy of any deduction from earnings order which [^{F278}it] makes under this section on—
 - (a) the person who appears to the [^{F277}Commission] to have the liable person in question in his employment; and
 - (b) the liable person.

35 Enforcement of liability orders by distress.

- (1) Where a liability order has been made against a person (“the liable person”), the [^{F292}Commission] may levy the appropriate amount by distress and sale of the liable person’s goods.
- (2) In subsection (1), “the appropriate amount” means the aggregate of—
- the amount in respect of which the order was made, to the extent that it remains unpaid; and
 - an amount, determined in such manner as may be prescribed, in respect of the charges connected with the distress.

General rule

- 1 (1) The weekly rate of child support maintenance is the basic rate unless a reduced rate, a flat rate or the nil rate applies.
- (2) Unless the nil rate applies, the amount payable weekly to a person with care is—
- (a) the applicable rate, if paragraph 6 does not apply; or
 - (b) if paragraph 6 does apply, that rate as apportioned between the persons with care in accordance with paragraph 6,
- as adjusted, in either case, by applying the rules about shared care in paragraph 7 or 8.

Basic rate

- 2 (1) The basic rate is the following percentage of the non-resident parent's net weekly income—
- 15% where he has one qualifying child;
 - 20% where he has two qualifying children;
 - 25% where he has three or more qualifying children.

Nil rate

- 5 The rate payable is nil if the non-resident parent—
- (a) is of a prescribed description; or
 - (b) has a net weekly income of below £5.

Apportionment

- 6 (1) If the non-resident parent has more than one qualifying child and in relation to them there is more than one person with care, the amount of child support maintenance payable is (subject to paragraph 7 or 8) to be determined by apportioning the rate between the persons with care.
