



Child Support Act 1991

1991 CHAPTER 48

An Act to make provision for the [^{F1}calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

The basic principles

1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [^{F2}a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [^{F3}maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made to make those payments.

2 Welfare of children: the general principle.

Where, in any case which falls to be dealt with under this Act, the [^{F4}Secretary of State]^{F5}... is considering the exercise of any discretionary power conferred by this Act, [^{F6}the Secretary of State] shall have regard to the welfare of any child likely to be affected by [^{F7}the] decision.

3 Meaning of certain terms used in this Act.

- (1) A child is a “qualifying child” if—
 - (a) one of his parents is, in relation to him, [^{F2}a non-resident parent]; or
 - (b) both of his parents are, in relation to him, [^{F2}non-resident parents].
- (2) The parent of any child is [^{F2}a “non-resident parent”], in relation to him, if—
 - (a) that parent is not living in the same household with the child; and
 - (b) the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
 - (a) with whom the child has his home;
 - (b) who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
 - (c) who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
 - (a) parents;
 - (b) guardians;
 - (c) persons in whose favour residence orders under section 8 of the ^{M1}Children Act 1989 are in force;
 - (d) in Scotland, persons [^{F8}with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [^{F3}maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

4 Child support maintenance.

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the [^{F2}non-resident parent] may apply to the [^{F9}Secretary of State] for a [^{F3}maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a [^{F3}maintenance calculation] has been made in response to an application under this section the [^{F10}Secretary of State] may, if the person with care or [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made applies to [^{F10}the Secretary of State] under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the [^{F1}calculation];
 - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [^{F1}calculation].
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the [^{F11}Secretary of State] to take steps to enforce that obligation whenever [^{F11}the Secretary of State] considers it necessary to do so, the [^{F11}Secretary of State] may act accordingly.

- (4) A person who applies to the ^{F12}Secretary of State] under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the ^{F12}Secretary of State]^{F13}... being provided with the information which is required to enable—
 - (a) the ^{F2}non-resident parent] to be ^{F14}identified or] traced (where that is necessary);
 - (b) the amount of child support maintenance payable by the ^{F2}non-resident parent] to be assessed; and
 - (c) that amount to be recovered from the ^{F2}non-resident parent].
- (5) Any person who has applied to the ^{F15}Secretary of State] under this section may at any time request ^{F15}the Secretary of State] to cease acting under this section.
- (6) It shall be the duty of the ^{F16}Secretary of State] to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).
- (7) The obligation to provide information which is imposed by subsection (4)—
 - (a) shall not apply in such circumstances as may be prescribed; and
 - (b) may, in such circumstances as may be prescribed, be waived by the ^{F17}Secretary of State].

5 Child support maintenance: supplemental provisions.

- (1) Where—
- (a) there is more than one person with care of a qualifying child; and
 - (b) one or more, but not all, of them have parental responsibility for ^{F25}... the child; no application may be made for a [^{F3}maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for ^{F25}... the child.
- (2) Where more than one application for a [^{F3}maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.
- (3) The Secretary of State may by regulations make provision as to which of two or more applications for a [^{F3}maintenance calculation] with respect to the same child is to be proceeded with.

8 Role of the courts with respect to maintenance for children.

9 Agreements about maintenance.

- (1) In this section “maintenance agreement” means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.
- (2) Nothing in this Act shall be taken to prevent any person from entering into a maintenance agreement.
- ^{F52}(2A) The ^{F53}[Secretary of State] may, with a view to reducing the need for applications under sections 4 and 7—
- take such steps as ^{F54}[the Secretary of State] considers appropriate to encourage the making and keeping of maintenance agreements, and
 - in particular, before accepting an application under those sections, invite the applicant to consider with the ^{F55}[Secretary of State] whether it is possible to make such an agreement.]

31 Deduction from earnings orders.

- (1) This section applies where any person (“the liable person”) is liable to make payments of child support maintenance.
- (2) The [^{F316}Secretary of State] may make an order (“a deduction from earnings order”) against a liable person to secure the payment of any amount due under the [^{F3}maintenance calculation] in question.
