



# Child Support Act 1991

## 1991 CHAPTER 48

### E+W+S

An Act to make provision for the [<sup>F1</sup>calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

### *The basic principles*

#### 1 **The duty to maintain.** E+W+S

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [<sup>F2</sup>a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [<sup>F3</sup>maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [<sup>F2</sup>non-resident parent] with respect to whom the [<sup>F1</sup>calculation] was made to make those payments.

#### 2 **Welfare of children: the general principle.** E+W+S

Where, in any case which falls to be dealt with under this Act, the [<sup>F4</sup>Secretary of State]<sup>F5</sup>... is considering the exercise of any discretionary power conferred by this Act, [<sup>F6</sup>the Secretary of State] shall have regard to the welfare of any child likely to be affected by [<sup>F7</sup>the] decision.

### 3 Meaning of certain terms used in this Act. **E+W+S**

- (1) A child is a “qualifying child” if—
- one of his parents is, in relation to him, [<sup>F2</sup>a non-resident parent]; or
  - both of his parents are, in relation to him, [<sup>F2</sup>non-resident parents].
- (2) The parent of any child is [<sup>F2</sup>a “non-resident parent”], in relation to him, if—
- that parent is not living in the same household with the child; and
  - the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
- with whom the child has his home;
  - who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
  - who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
- parents;
  - guardians;
  - [<sup>F8</sup>(c) persons named, in a child arrangements order under section 8 of the Children Act 1989, as persons with whom a child is to live;]
  - in Scotland, persons [<sup>F9</sup>with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [<sup>F3</sup>maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

## 4 Child support maintenance. **E+W+S**

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the [<sup>F2</sup>non-resident parent] may apply to the [<sup>F10</sup>Secretary of State] for a [<sup>F3</sup>maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a [<sup>F3</sup>maintenance calculation] has been made in response to an application under this section the [<sup>F11</sup>Secretary of State] may, if the person with care or [<sup>F2</sup>non-resident parent] with respect to whom the [<sup>F1</sup>calculation] was made applies to [<sup>F11</sup>the Secretary of State] under this subsection, arrange for—
  - (a) the collection of the child support maintenance payable in accordance with the [<sup>F1</sup>calculation];
  - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [<sup>F1</sup>calculation].
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the [<sup>F12</sup>Secretary of State] to take steps to enforce that obligation whenever [<sup>F12</sup>the Secretary of State] considers it necessary to do so, the [<sup>F12</sup>Secretary of State] may act accordingly.
- (4) A person who applies to the [<sup>F13</sup>Secretary of State] under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the

### 5 Child support maintenance: supplemental provisions. **E+W+S**

- (1) Where—
- (a) there is more than one person with care of a qualifying child; and
  - (b) one or more, but not all, of them have parental responsibility for <sup>F26</sup>... the child; no application may be made for a [<sup>F3</sup>maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for <sup>F26</sup>... the child.
- (2) Where more than one application for a [<sup>F3</sup>maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.
- (3) The Secretary of State may by regulations make provision as to which of two or more applications for a [<sup>F3</sup>maintenance calculation] with respect to the same child is to be proceeded with.

- (3) Where a <sup>F3</sup>maintenance calculation] has been made in response to an application under this section the <sup>F30</sup>Secretary of State] may, if the person with care, the <sup>F2</sup>non-resident parent] with respect to whom the <sup>F1</sup>calculation] was made or the child concerned applies to <sup>F30</sup>the Secretary of State] under this subsection, arrange for—
- (a) the collection of the child support maintenance payable in accordance with the <sup>F1</sup>calculation];
- (b) the enforcement of the obligation to pay child support maintenance in accordance with the <sup>F1</sup>calculation].
- (4) Where an application under subsection (3) for the enforcement of the obligation mentioned in subsection (3)(b) authorises the <sup>F31</sup>Secretary of State] to take steps to enforce that obligation whenever <sup>F31</sup>the Secretary of State] considers it necessary to do so, the <sup>F31</sup>Secretary of State] may act accordingly.
- (5) Where a child has asked the <sup>F32</sup>Secretary of State] to proceed under this section, the person with care of the child, the <sup>F2</sup>non-resident parent] and the child concerned shall, so far as they reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the <sup>F32</sup>Secretary of State] <sup>F33</sup>... being provided with the information which is required to enable—
- (a) the <sup>F2</sup>non-resident parent] to be traced (where that is necessary);
- (b) the amount of child support maintenance payable by the <sup>F2</sup>non-resident parent] to be assessed; and
- (c) that amount to be recovered from the <sup>F2</sup>non-resident parent].
- (6) The child who has made the application (but not the person having care of him) may at any time request the <sup>F34</sup>Secretary of State] to cease acting under this section.
- (7) It shall be the duty of the <sup>F34</sup>Secretary of State] to comply with any request made under subsection (6) (but subject to any regulations made under subsection (9)).
- (8) The obligation to provide information which is imposed by subsection (5)—
- (a) shall not apply in such circumstances as may be prescribed by the Secretary of State; and
- (b) may, in such circumstances as may be so prescribed, be waived by the <sup>F35</sup>Secretary of State].
- (9) The Secretary of State may by regulations make such incidental, supplemental or transitional provision as he thinks appropriate with respect to cases in which he is requested to cease to act under this section.
- <sup>F36</sup>(10) No application may be made at any time under this section by a qualifying child if
- <sup>F37</sup>(a) [ there is in force a written maintenance agreement made before 5th April 1993, or a maintenance order <sup>F38</sup>made before a prescribed date], in respect of that child and the person who is, at that time, the <sup>F2</sup>non-resident parent]] <sup>F39</sup>or

## 8 Role of the courts with respect to maintenance for children. **E+W+S**

- (1) This subsection applies in any case where [<sup>F41</sup>the [<sup>F42</sup>Secretary of State]] would have jurisdiction to make a [<sup>F3</sup>maintenance calculation] with respect to a qualifying child and [<sup>F2</sup>a non-resident parent] of his on an application duly made <sup>F43</sup>... by a person entitled to apply for such [<sup>F1</sup>a calculation] with respect to that child.
  - (2) Subsection (1) applies even though the circumstances of the case are such that [<sup>F41</sup>the [<sup>F42</sup>Secretary of State]] would not make [<sup>F1</sup>a calculation] if it were applied for.
  - (3) [<sup>F44</sup>Except as provided in subsection (3A),] in any case where subsection (1) applies, no court shall exercise any power which it would otherwise have to make, vary or revive any maintenance order in relation to the child and [<sup>F2</sup>non-resident parent] concerned.

- (a) a [<sup>F3</sup>maintenance calculation] is in force with respect to the child;

  - (b) the order is made solely for the purposes of requiring the person making or securing the making of periodical payments fixed by the order to meet some or all of the expenses incurred in connection with the provision of the instruction or training.
- (8) This section shall not prevent a court from exercising any power which it has to make a maintenance order in relation to a child if—
- (a) [<sup>F49</sup>an allowance under Part 4 of the Welfare Reform Act 2012 (personal independence payment) or] a disability living allowance is paid to or in respect of him; or
  - (b) no such allowance is paid but he is disabled,
- and the order is made solely for the purpose of requiring the person making or securing the making of periodical payments fixed by the order to meet some or all of any expenses attributable to the child's disability.
- (9) For the purposes of subsection (8), a child is disabled if he is blind, deaf or dumb or is substantially and permanently handicapped by illness, injury, mental disorder or congenital deformity or such other disability as may be prescribed.
- (10) This section shall not prevent a court from exercising any power which it has to make a maintenance order in relation to a child if the order is made against a person with care of the child.
- (11) In this Act “maintenance order”, in relation to any child, means an order which requires the making or securing of periodical payments to or for the benefit of the child and which is made under—
- (a) Part II of the <sup>M1</sup>Matrimonial Causes Act 1973;

## 9 Agreements about maintenance. **E+W+S**

- (1) In this section “maintenance agreement” means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.
- (2) Nothing in this Act shall be taken to prevent any person from entering into a maintenance agreement.
- <sup>F53</sup>(2A) The <sup>F54</sup>[Secretary of State] may, with a view to reducing the need for applications under sections 4 and 7—
- take such steps as <sup>F55</sup>[the Secretary of State] considers appropriate to encourage the making and keeping of maintenance agreements, and
  - in particular, before accepting an application under those sections, invite the applicant to consider with the <sup>F56</sup>[Secretary of State] whether it is possible to make such an agreement.]
- (3) <sup>F57</sup>[Subject to section 4(10)(a) <sup>F58</sup>[and (ab)] and section 7(10),] the existence of a maintenance agreement shall not prevent any party to the agreement, or any other person, from applying for a <sup>F3</sup>[maintenance calculation] with respect to any child to or for whose benefit periodical payments are to be made or secured under the agreement.
- (4) Where any agreement contains a provision which purports to restrict the right of any person to apply for a <sup>F3</sup>[maintenance calculation], that provision shall be void.
- (5) Where section 8 would prevent any court from making a maintenance order in relation to a child and <sup>F2</sup>[a non-resident parent] of his, no court shall exercise any power that it has to vary any agreement so as—
- to insert a provision requiring that <sup>F2</sup>[non-resident parent] to make or secure the making of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of that child; or
  - to increase the amount payable under such a provision.

## 10 Relationship between maintenance [<sup>F1</sup>calculations] and certain court orders and related matters. **E+W+S**

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [<sup>F3</sup>maintenance calculation] is made, the order—
  - (a) shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or

- (2) Where an agreement of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [<sup>F3</sup>maintenance calculation] is made, the agreement—
  - (a) shall, so far as it relates to the making or securing of periodical payments, be unenforceable to such extent as may be determined in accordance with regulations made by the Secretary of State; or
  - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (3) Any regulations under this section may, in particular, make such provision with respect to—
  - (a) any case where any person with respect to whom an order or agreement of a kind prescribed for the purposes of subsection (1) or (2) has effect applies to the prescribed court, before the end of the prescribed period, for the order or agreement to be varied in the light of the [<sup>F3</sup>maintenance calculation] and of the provisions of this Act;
  - (b) the recovery of any arrears under the order or agreement which fell due before the coming into force of the [<sup>F3</sup>maintenance calculation],  
as the Secretary of State considers appropriate and may provide that, in prescribed circumstances, an application to any court which is made with respect to an order of a prescribed kind relating to the making or securing of periodical payments to or for the benefit of a child shall be treated by the court as an application for the order to be revoked.
- (4) The Secretary of State may by regulations make provision for—
  - (a) notification to be given by [<sup>F61</sup>the [<sup>F62</sup>Secretary of State]] to the prescribed person in any case where [<sup>F62</sup>the Secretary of State] considers that the making of a [<sup>F3</sup>maintenance calculation] has affected, or is likely to affect, any order of a kind prescribed for the purposes of this subsection;

## 15 Powers of inspectors. **E+W+S**

[<sup>F94</sup>(1) The [<sup>F95</sup>Secretary of State] may appoint, on such terms as [<sup>F95</sup>the Secretary of State] thinks fit, persons to act as inspectors under this section.

(2) The function of inspectors is to acquire information which the [<sup>F96</sup>the Secretary of State] needs for any of the purposes of this Act.

(3) Every inspector is to be given a certificate of his appointment.

(4) An inspector has power, at any reasonable time and either alone or accompanied by such other persons as he thinks fit, to enter any premises which—

(a) are liable to inspection under this section; and

(b) are premises to which it is reasonable for him to require entry in order that he may exercise his functions under this section,

and may there make such examination and inquiry as he considers appropriate.

(4A) Premises liable to inspection under this section are those which are not used wholly as a dwelling house and which the inspector has reasonable grounds for suspecting are—

he shall be guilty of an offence and liable on summary conviction to a fine not exceeding level 3 on the standard scale.

**31 Deduction from earnings orders. E+W+S**

- (1) This section applies where any person (“the liable person”) is liable to make payments of child support maintenance.
- (2) The [F319Secretary of State] may make an order (“a deduction from earnings order”) against a liable person to secure the payment of any amount due under the [F3maintenance calculation] in question.
- (3) A deduction from earnings order may be made so as to secure the payment of—
  - (a) arrears of child support maintenance payable under the [F1calculation];
  - (b) amounts of child support maintenance which will become due under the [F1calculation]; or
  - (c) both such arrears and such future amounts.
- (4) A deduction from earnings order—
  - (a) shall be expressed to be directed at a person (“the employer”) who has the liable person in his employment; and
  - (b) shall have effect from such date as may be specified in the order.
- (5) A deduction from earnings order shall operate as an instruction to the employer to—
  - (a) make deductions from the liable person’s earnings; and
  - (b) pay the amounts deducted to the [F320Secretary of State].
- (6) The [F321Secretary of State] shall serve a copy of any deduction from earnings order [F321made] under this section on—
  - (a) the person who appears to the [F321Secretary of State] to have the liable person in question in his employment; and
  - (b) the liable person.
- (7) Where—

  - (b) a copy of the order has been served on the liable person’s employer,it shall be the duty of that employer to comply with the order; but he shall not be under any liability for non-compliance before the end of the period of 7 days beginning with the date on which the copy was served on him.

### 32 Regulations about deduction from earnings orders. **E+W+S**

- (1) The Secretary of State may by regulations make provision with respect to deduction from earnings orders.
- (2) The regulations may, in particular, make provision—

### 32B Orders under section 32A: joint accounts **E+W+S**

    - (ii) of any other accounts held with the deposit-taker at that time by the person against whom the order is made;

    - (i) the account specified in the order is closed;

  - (k) as to circumstances in which the deposit-taker at which an order is directed, the person against whom the order is made and (in the case of an order made in respect of a joint account) the other account-holders may apply to the [<sup>F331</sup>Secretary of State] for [<sup>F332</sup>the Secretary of State] to review the order and as to such a review;
  - (l) for the variation of orders;
  - (m) similar to that made by section 32A(8), in relation to any variation of an order;
  - (n) for an order to lapse in such circumstances as may be prescribed;
  - (o) as to the revival of an order in such circumstances as may be prescribed;
  - (p) allowing or requiring an order to be discharged;
  - (q) as to the giving of notice by the [<sup>F331</sup>Secretary of State] to the deposit-taker that an order has lapsed or ceased to have effect.

### 32D Orders under section 32A: offences **E+W+S**

- (1) A person who fails to comply with the requirements of—
- (a) an order under section 32A, or
  - (b) any regulation under section 32C which is designated by the regulations for the purposes of this paragraph,
- commits an offence.
- (2) It shall be a defence for a person charged with an offence under subsection (1) to prove that the person took all reasonable steps to comply with the requirements in question.

### 32F Lump sum deductions: final orders **E+W+S**

- (1) The [<sup>F338</sup>Secretary of State] may make an order under this section in pursuance of a proposal specified in an order under section 32E if—
- (a) the order in which the proposal was specified (“the interim order”) is in force;

### 32G Orders under sections 32E and 32F: freezing of accounts etc. **E+W+S**

- (1) During the relevant period, an order under section 32E or 32F which specifies an account held with a deposit-taker shall operate as an instruction to the deposit-taker not to do anything that would reduce the amount standing to the credit of the account below the amount specified in the order (or, if already below that amount, that would further reduce it).

### 33 Liability orders. **E+W+S**

### 57 Application to Crown. **E+W+S**

- (1) The power of the Secretary of State to make regulations under section 14 requiring prescribed persons to furnish information may be exercised so as to require information to be furnished by persons employed in the service of the Crown or otherwise in the discharge of Crown functions.

- (2) Section 56(1) and subsections (1) to (11) and (14) of this section shall come into force on the passing of this Act but otherwise this Act shall come into force on such date as may be appointed by order made by the Lord Chancellor, the Secretary of State or Lord Advocate, or by any of them acting jointly.
- (3) Different dates may be appointed for different provisions of this Act and for different purposes (including, in particular, for different cases or categories of case).
- (4) An order under subsection (2) may make such supplemental, incidental or transitional provision as appears to the person making the order to be necessary or expedient in connection with the provisions brought into force by the order, including such adaptations or modifications of—
  - (a) the provisions so brought into force;
  - (b) any provisions of this Act then in force; or
  - (c) any provision of any other enactment,
 as appear to him to be necessary or expedient.
- (5) Different provision may be made by virtue of subsection (4) with respect to different periods.
- (6) Any provision made by virtue of subsection (4) may, in particular, include provision for—

- (b) the registration of maintenance [<sup>F1</sup>calculations] with the appropriate court in connection with any provision of a kind mentioned in paragraph (a);
- (c) the variation, on application made to a court, of the provisions of a [<sup>F3</sup>maintenance calculation] relating to the method of making payments fixed by the [<sup>F1</sup>calculation] or the intervals at which such payments are to be made;
- (d) a [<sup>F3</sup>maintenance calculation], or an order of a prescribed kind relating to one or more children, to be deemed, in prescribed circumstances, to have been validly made for all purposes or for such purposes as may be prescribed.

In paragraph (c) “court” includes a single justice.

- (7) The Lord Chancellor, the Secretary of State or the Lord Advocate may by order make such amendments or repeals in, or such modifications of, such enactments as may be specified in the order, as appear to him to be necessary or expedient in consequence of any provision made by or under this Act (including any provision made by virtue of subsection (4)).
- (8) This Act shall, in its application to the Isles of Scilly, have effect subject to such exceptions, adaptations and modifications as the Secretary of State may by order prescribe.
- (9) Sections 27, 35<sup>F496</sup>, 40] and 48 and paragraph 7 of Schedule 5 do not extend to Scotland.
- (10) Sections 7, 28<sup>F497</sup>, 40A] and 49 extend only to Scotland.

#### *Property or capital transfers*

- 3 (1) A variation may be agreed in the circumstances set out in sub-paragraph (2) if before 5th April 1993—
  - (a) a court order of a prescribed kind was in force with respect to the non-resident parent and either the person with care with respect to the application for the maintenance calculation or the child, or any of the children, with respect to whom that application was made; or
