



# Child Support Act 1991

## 1991 CHAPTER 48

An Act to make provision for the [<sup>F1</sup>calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

### *The basic principles*

## 1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [<sup>F2</sup>a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [<sup>F3</sup>maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [<sup>F2</sup>non-resident parent] with respect to whom the [<sup>F1</sup>calculation] was made to make those payments.

## 2 Welfare of children: the general principle.

Where, in any case which falls to be dealt with under this Act, the [<sup>F4</sup>Secretary of State]<sup>F5</sup>... is considering the exercise of any discretionary power conferred by this Act, [<sup>F6</sup>the Secretary of State] shall have regard to the welfare of any child likely to be affected by [<sup>F7</sup>the] decision.

### 3 Meaning of certain terms used in this Act.

- (1) A child is a “qualifying child” if—
- one of his parents is, in relation to him, [<sup>F2</sup>a non-resident parent]; or
  - both of his parents are, in relation to him, [<sup>F2</sup>non-resident parents].
- (2) The parent of any child is [<sup>F2</sup>a “non-resident parent”], in relation to him, if—
- that parent is not living in the same household with the child; and
  - the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
- with whom the child has his home;
  - who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
  - who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
- parents;
  - guardians;
  - [<sup>F8</sup>(c) persons named, in a child arrangements order under section 8 of the Children Act 1989, as persons with whom a child is to live;]
  - in Scotland, persons [<sup>F9</sup>with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [<sup>F3</sup>maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

## 4 Child support maintenance.

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the <sup>F2</sup>non-resident parent] may apply to the <sup>F10</sup>Secretary of State] for a <sup>F3</sup>maintenance calculation] to be made under this Act with respect to that child, or any of those children.
  - (2) Where a <sup>F3</sup>maintenance calculation] has been made in response to an application under this section the <sup>F11</sup>Secretary of State] may, if the person with care <sup>F12</sup>... applies to <sup>F11</sup>the Secretary of State] under this subsection, arrange for—
    - (a) the collection of the child support maintenance payable in accordance with the <sup>F1</sup>calculation];
    - (b) the enforcement of the obligation to pay child support maintenance in accordance with the <sup>F1</sup>calculation].
- <sup>F13</sup>(2A) The <sup>F14</sup>Secretary of State] may only make arrangements under subsection (2)(a) if—
- (a) the non-resident parent agrees to the arrangements, or
  - (b) the <sup>F14</sup>Secretary of State] is satisfied that without the arrangements child support maintenance is unlikely to be paid in accordance with the calculation.]
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the <sup>F15</sup>Secretary of State] to take steps to

enforce that obligation whenever [<sup>F15</sup>the Secretary of State] considers it necessary to do so, the [<sup>F15</sup>Secretary of State] may act accordingly.

- (4) A person who applies to the [<sup>F16</sup>Secretary of State] under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the [<sup>F16</sup>Secretary of State]<sup>F17</sup>... being provided with the information which is required to enable—
- (a) the [<sup>F2</sup>non-resident parent] to be [<sup>F18</sup>identified or] traced (where that is necessary);
  - (b) the amount of child support maintenance payable by the [<sup>F2</sup>non-resident parent] to be assessed; and
  - (c) that amount to be recovered from the [<sup>F2</sup>non-resident parent].
- (5) Any person who has applied to the [<sup>F19</sup>Secretary of State] under this section may at any time request [<sup>F19</sup>the Secretary of State] to cease acting under this section.
- (6) It shall be the duty of the [<sup>F20</sup>Secretary of State] to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).
- (7) The obligation to provide information which is imposed by subsection (4)—
- (a) shall not apply in such circumstances as may be prescribed; and
  - (b) may, in such circumstances as may be prescribed, be waived by the [<sup>F21</sup>Secretary of State].
- (8) The Secretary of State may by regulations make such incidental, supplemental or transitional provision as he thinks appropriate with respect to cases in which he is requested to cease to act under this section.

[<sup>F23</sup>(10) No application may be made at any time under this section with respect to a qualifying child or any qualifying children if—

- (a) there is in force a written maintenance agreement made before 5th April 1993, or a maintenance order [<sup>F24</sup>made before a prescribed date], in respect of that child or those children and the person who is, at that time, the [<sup>F2</sup>non-resident parent]; or

[<sup>F25</sup>(aa) a maintenance order made on or after the date prescribed for the purposes of paragraph (a) is in force in respect of them, but has been so for less than the period of one year beginning with the date on which it was made; or]

[<sup>F26</sup>(ab) a maintenance agreement—

## **5 Child support maintenance: supplemental provisions.**

- (1) Where—
  - (a) there is more than one person with care of a qualifying child; and
  - (b) one or more, but not all, of them have parental responsibility for <sup>F29</sup>... the child; no application may be made for a [<sup>F3</sup>maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for <sup>F29</sup>... the child.
- (2) Where more than one application for a [<sup>F3</sup>maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.
- (3) The Secretary of State may by regulations make provision as to which of two or more applications for a [<sup>F3</sup>maintenance calculation] with respect to the same child is to be proceeded with.

## 7 Right of child in Scotland to apply for [F<sup>1</sup> calculation].

- (1) A qualifying child who has attained the age of 12 years and who is habitually resident in Scotland may apply to the [F<sup>31</sup>Secretary of State] for a [F<sup>3</sup> maintenance calculation] to be made with respect to him if—
  - (a) no such application has been made by a person who is, with respect to that child, a person with care or [F<sup>2</sup>a non-resident parent]; F<sup>32</sup> ...
  - F<sup>32</sup>(b) .....
- (2) An application made under subsection (1) shall authorise the [F<sup>31</sup>Secretary of State] to make a [F<sup>3</sup> maintenance calculation] with respect to any other children of the [F<sup>2</sup>non-resident parent] who are qualifying children in the care of the same person as the child making the application.
- (3) Where a [F<sup>3</sup> maintenance calculation] has been made in response to an application under this section the [F<sup>33</sup>Secretary of State] may, if the [F<sup>34</sup>person with care or] the child concerned applies to [F<sup>33</sup>the Secretary of State] under this subsection, arrange for—
  - (a) the collection of the child support maintenance payable in accordance with the [F<sup>1</sup> calculation];

## 8 Role of the courts with respect to maintenance for children.

- (1) This subsection applies in any case where [<sup>F47</sup>the [<sup>F48</sup>Secretary of State]] would have jurisdiction to make a [<sup>F3</sup>maintenance calculation] with respect to a qualifying child and [<sup>F2</sup>a non-resident parent] of his on an application duly made [<sup>F49</sup>... by a person entitled to apply for such [<sup>F1</sup>a calculation] with respect to that child.

**10 Relationship between maintenance [<sup>F1</sup>calculations] and certain court orders and related matters.**

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [<sup>F3</sup>maintenance calculation] is made, the order—
- (a) shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or

## 15 Powers of inspectors.

- [<sup>F100</sup>(1) The [<sup>F101</sup>Secretary of State] may appoint, on such terms as [<sup>F101</sup>the Secretary of State] thinks fit, persons to act as inspectors under this section.
- (2) The function of inspectors is to acquire information which the [<sup>F102</sup>the Secretary of State] needs for any of the purposes of this Act.
- (3) Every inspector is to be given a certificate of his appointment.
- (4) An inspector has power, at any reasonable time and either alone or accompanied by such other persons as he thinks fit, to enter any premises which—
- (a) are liable to inspection under this section; and
  - (b) are premises to which it is reasonable for him to require entry in order that he may exercise his functions under this section,
- and may there make such examination and inquiry as he considers appropriate.
- (4A) Premises liable to inspection under this section are those which are not used wholly as a dwelling house and which the inspector has reasonable grounds for suspecting are—
- (a) premises at which a non-resident parent is or has been employed;
  - (b) premises at which a non-resident parent carries out, or has carried out, a trade, profession, vocation or business;
  - (c) premises at which there is information held by a person (“A”) whom the inspector has reasonable grounds for suspecting has information about a non-resident parent acquired in the course of A’s own trade, profession, vocation or business.]
- (5) An inspector exercising his powers may question any person aged 18 or over whom he finds on the premises.
- (6) If required to do so by an inspector exercising his powers, [<sup>F103</sup>any such person] shall furnish to the inspector all such information and documents as the inspector may reasonably require.

### 30 Collection and enforcement of other forms of maintenance.

- (1) Where the [<sup>F320</sup>Secretary of State] is arranging for the collection of any payments under section 29 or subsection (2), [<sup>F320</sup>the Secretary of State] may also arrange for the collection of any periodical payments, or secured periodical payments, of a prescribed kind which are payable to or for the benefit of any person who falls within a prescribed category.
- [<sup>F321</sup>(2) The [<sup>F320</sup>Secretary of State] may, except in prescribed cases, arrange for the collection of any periodical payments, or secured periodical payments, of a prescribed kind which are payable for the benefit of a child even though [<sup>F320</sup>the Secretary of State] is not arranging for the collection of child support maintenance with respect to that child.]
- (3) Where—
- the [<sup>F322</sup>Secretary of State] is arranging, under this Act, for the collection of different payments (“the payments”) from the same [<sup>F2</sup>non-resident parent];
  - an amount is collected by the [<sup>F322</sup>Secretary of State] from the [<sup>F2</sup>non-resident parent] which is less than the total amount due in respect of the payments; and

**31 Deduction from earnings orders.**

- (1) This section applies where any person (“the liable person”) is liable to make payments of child support maintenance.
- (2) The [<sup>F326</sup>Secretary of State] may make an order (“a deduction from earnings order”) against a liable person to secure the payment of any amount due under the [<sup>F3</sup>maintenance calculation] in question.
- (3) A deduction from earnings order may be made so as to secure the payment of—
  - (a) arrears of child support maintenance payable under the [<sup>F1</sup>calculation];
  - (b) amounts of child support maintenance which will become due under the [<sup>F1</sup>calculation]; or
  - (c) both such arrears and such future amounts.
- (4) A deduction from earnings order—
  - (a) shall be expressed to be directed at a person (“the employer”) who has the liable person in his employment; and
  - (b) shall have effect from such date as may be specified in the order.
- (5) A deduction from earnings order shall operate as an instruction to the employer to—
  - (a) make deductions from the liable person’s earnings; and
  - (b) pay the amounts deducted to the [<sup>F327</sup>Secretary of State].
- (6) The [<sup>F328</sup>Secretary of State] shall serve a copy of any deduction from earnings order [<sup>F328</sup>made] under this section on—
  - (a) the person who appears to the [<sup>F328</sup>Secretary of State] to have the liable person in question in his employment; and

## 32 Regulations about deduction from earnings orders.

- (1) The Secretary of State may by regulations make provision with respect to deduction from earnings orders.
- (2) The regulations may, in particular, make provision—
- (a) as to the circumstances in which one person is to be treated as employed by another;
  - (b) requiring any deduction from earnings under an order to be made in the prescribed manner;
  - [<sup>F329</sup>(bb) for the amount or amounts which are to be deducted from the liable person’s earnings not to exceed a prescribed proportion of his earnings (as determined by the employer);]

- (c) requiring an order to specify the amount or amounts to which the order relates and the amount or amounts which are to be deducted from the liable person's earnings in order to meet his liabilities under the [F<sup>3</sup> maintenance calculation] in question;
  - (d) requiring the intervals between deductions to be made under an order to be specified in the order;
  - (e) as to the payment of sums deducted under an order to the [F<sup>330</sup> Secretary of State];
  - (f) allowing the person who deducts and pays any amount under an order to deduct from the liable person's earnings a prescribed sum towards his administrative costs;
  - (g) with respect to the notification to be given to the liable person of amounts deducted, and amounts paid, under the order;
  - (h) requiring any person on whom a copy of an order is served to notify the [F<sup>330</sup> Secretary of State] in the prescribed manner and within a prescribed period if he does not have the liable person in his employment or if the liable person ceases to be in his employment;
  - (i) as to the operation of an order where the liable person is in the employment of the Crown;
  - (j) for the variation of orders;
  - (k) similar to that made by section 31(7), in relation to any variation of an order;
  - (l) for an order to lapse when the employer concerned ceases to have the liable person in his employment;
  - (m) as to the revival of an order in such circumstances as may be prescribed;
  - (n) allowing or requiring an order to be discharged;
  - (o) as to the giving of notice by the [F<sup>330</sup> Secretary of State] to the employer concerned that an order has lapsed or has ceased to have effect.
- (3) The regulations may include provision that while a deduction from earnings order is in force—
- (a) the liable person shall from time to time notify the [F<sup>330</sup> Secretary of State], in the prescribed manner and within a prescribed period, of each occasion on which he leaves any employment or becomes employed, or re-employed, and shall include in such a notification a statement of his earnings and expected earnings from the employment concerned and of such other matters as may be prescribed;
  - (b) any person who becomes the liable person's employer and knows that the order is in force shall notify the [F<sup>330</sup> Secretary of State], in the prescribed manner and within a prescribed period, that he is the liable person's employer, and shall include in such a notification a statement of the liable person's earnings and expected earnings from the employment concerned and of such other matters as may be prescribed.
- (4) The regulations may include provision with respect to the priority as between a deduction from earnings order and—
- (a) any other deduction from earnings order;
  - (b) any order under any other enactment relating to England and Wales which provides for deductions from the liable person's earnings;
  - (c) any diligence against earnings.

### **[<sup>F332</sup>32A Orders for regular deductions from accounts**

- (1) If in relation to any person it appears to the [<sup>F333</sup>Secretary of State]—
  - (a) that the person has failed to pay an amount of child support maintenance; and
  - (b) that the person holds an account with a deposit-taker;

[<sup>F333</sup>the Secretary of State] may make an order against that person to secure the payment of any amount due under the maintenance calculation in question by means of regular deductions from the account.
- (2) An order under this section may be made so as to secure the payment of—
  - (a) arrears of child support maintenance payable under the calculation;
  - (b) amounts of child support maintenance which will become payable under the calculation; or
  - (c) both such arrears and such future amounts.
- (3) An order under this section may be made in respect of amounts due under a maintenance calculation which is the subject of an appeal only if it appears to the [<sup>F334</sup>Secretary of State]—
  - (a) that liability for the amounts would not be affected were the appeal to succeed; or
  - (b) where paragraph (a) does not apply, that the making of an order under this section in respect of the amounts would nonetheless be fair in all the circumstances.
- (4) An order under this section—
  - (a) may not be made in respect of an account of a prescribed description; and
  - (b) may be made in respect of a joint account which is held by the person against whom the order is made and one or more other persons, and which is not of a description prescribed under paragraph (a), if (but only if) regulations made by the Secretary of State so provide.

  - (b) shall be expressed to be directed at the deposit-taker with which the account is held; and

### 32B Orders under section 32A: joint accounts

### **32G Orders under sections 32E and 32F: freezing of accounts etc.**

## 51 Supplementary powers to make regulations.

### 57 Application to Crown.

- (1) The power of the Secretary of State to make regulations under section 14 requiring prescribed persons to furnish information may be exercised so as to require information to be furnished by persons employed in the service of the Crown or otherwise in the discharge of Crown functions.

  - (b) the registration of maintenance [<sup>F1</sup>calculations] with the appropriate court in connection with any provision of a kind mentioned in paragraph (a);
  - (c) the variation, on application made to a court, of the provisions of a [<sup>F3</sup>maintenance calculation] relating to the method of making payments fixed by the [<sup>F1</sup>calculation] or the intervals at which such payments are to be made;

#### THE CASES

##### *General*

- 1 (1) The cases in which a variation may be agreed are those set out in this Part of this Schedule or in regulations made under this Part.
- (2) In this Schedule “applicant” means the person whose application for a variation is being considered.

##### *Special expenses*

- 2 (1) A variation applied for by a non-resident parent may be agreed with respect to his special expenses.
- (2) In this paragraph “special expenses” means the whole, or any amount above a prescribed amount, or any prescribed part, of expenses which fall within a prescribed description of expenses.
- (3) In prescribing descriptions of expenses for the purposes of this paragraph, the Secretary of State may, in particular, make provision with respect to—
  - (a) costs incurred by a non-resident parent in maintaining contact with the child, or with any of the children, with respect to whom the application for a maintenance calculation has been made <sup>F580</sup> ... ;
  - (b) costs attributable to a long-term illness or disability of a relevant other child (within the meaning of paragraph 10C(2) of Schedule 1);

## PART II

### REGULATORY CONTROLS

- (3) Regulations under this paragraph may, in particular, make provision for a variation to result in—
- (a) a person's being treated as having more, or less, income than would be taken into account without the variation in a calculation under Part I of Schedule 1;
  - (b) a person's being treated as liable to pay a higher, or a lower, amount of child support maintenance than would result without the variation from a calculation under that Part.
- (4) Regulations may provide for the amount of any special expenses to be taken into account in a case falling within paragraph 2, for the purposes of a variation, not to exceed such amount as may be prescribed or as may be determined in accordance with the regulations.
- (5) Any regulations under this paragraph may in particular make different provision with respect to different levels of income.
- 6 The Secretary of State may by regulations provide for the application, in connection with child support maintenance payable following a variation, of paragraph 7(2) to (7) of Schedule 1 (subject to any prescribed modifications).]
