The basic principles

1 The duty to maintain. E+W+S

31 Deduction from earnings orders. E+W+S

- (1) This section applies where any person ("the liable person") is liable to make payments of child support maintenance.
- (2) The [F326Secretary of State] may make an order ("a deduction from earnings order") against a liable person to secure the payment of any amount due under the [F3 maintenance calculation] in question.
- (3) A deduction from earnings order may be made so as to secure the payment of—
 - (a) arrears of child support maintenance payable under the [F1 calculation];
 - (b) amounts of child support maintenance which will become due under the [F1calculation]; or
 - (c) both such arrears and such future amounts.
- (4) A deduction from earnings order—
 - (a) shall be expressed to be directed at a person ("the employer") who has the liable person in his employment; and
 - (b) shall have effect from such date as may be specified in the order.
- (5) A deduction from earnings order shall operate as an instruction to the employer to—
 - (a) make deductions from the liable person's earnings; and
 - (b) pay the amounts deducted to the [F327]Secretary of State].
- (6) The [F328 Secretary of State] shall serve a copy of any deduction from earnings order [F328 made] under this section on—
 - (a) the person who appears to the [F328]Secretary of State] to have the liable person in question in his employment; and
 - (b) the liable person.

- (2) The regulations may, in particular, make provision—
 - (a) as to the circumstances in which one person is to be treated as employed by another:
 - (b) requiring any deduction from earnings under an order to be made in the prescribed manner;
