An Act to make provision for the [F1calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

The basic principles

1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [F2 a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.

3 Meaning of certain terms used in this Act.

- (1) The appropriate court may issue a warrant authorising entry to premises if, on an application made by an inspector, the court is satisfied that—
 - (a) any of the conditions in subsection (2) is met, and
 - (b) each of the conditions in subsection (3) is met.


