



# Child Support Act 1991

## 1991 CHAPTER 48

An Act to make provision for the [<sup>F1</sup>calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

### *The basic principles*

## 1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [<sup>F2</sup>a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [<sup>F3</sup>maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [<sup>F2</sup>non-resident parent] with respect to whom the [<sup>F1</sup>calculation] was made to make those payments.

## 2 Welfare of children: the general principle.

Where, in any case which falls to be dealt with under this Act, the [<sup>F4</sup>Secretary of State]<sup>F5</sup>... is considering the exercise of any discretionary power conferred by this Act, [<sup>F6</sup>the Secretary of State] shall have regard to the welfare of any child likely to be affected by [<sup>F7</sup>the] decision.

### 3 Meaning of certain terms used in this Act.

- (1) A child is a “qualifying child” if—
- one of his parents is, in relation to him, [<sup>F2</sup>a non-resident parent]; or
  - both of his parents are, in relation to him, [<sup>F2</sup>non-resident parents].
- (2) The parent of any child is [<sup>F2</sup>a “non-resident parent”], in relation to him, if—
- that parent is not living in the same household with the child; and
  - the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
- with whom the child has his home;
  - who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
  - who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
- parents;
  - guardians;
  - [<sup>F8</sup>(c) persons named, in a child arrangements order under section 8 of the Children Act 1989, as persons with whom a child is to live;]
  - in Scotland, persons [<sup>F9</sup>with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [<sup>F3</sup>maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

## 4 Child support maintenance.

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the <sup>F2</sup>non-resident parent] may apply to the <sup>F10</sup>Secretary of State] for a <sup>F3</sup>maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a <sup>F3</sup>maintenance calculation] has been made in response to an application under this section the <sup>F11</sup>Secretary of State] may, if the person with care <sup>F12</sup>... applies to <sup>F11</sup>the Secretary of State] under this subsection, arrange for—
- the collection of the child support maintenance payable in accordance with the <sup>F1</sup>calculation];
  - the enforcement of the obligation to pay child support maintenance in accordance with the <sup>F1</sup>calculation].
- <sup>F13</sup>(2A) The <sup>F14</sup>Secretary of State] may only make arrangements under subsection (2)(a) if—
- the non-resident parent agrees to the arrangements, or
  - the <sup>F14</sup>Secretary of State] is satisfied that without the arrangements child support maintenance is unlikely to be paid in accordance with the calculation.]
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the <sup>F15</sup>Secretary of State] to take steps to

enforce that obligation whenever [<sup>F15</sup>the Secretary of State] considers it necessary to do so, the [<sup>F15</sup>Secretary of State] may act accordingly.

- (4) A person who applies to the [<sup>F16</sup>Secretary of State] under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the [<sup>F16</sup>Secretary of State]<sup>F17</sup>... being provided with the information which is required to enable—
- (a) the [<sup>F2</sup>non-resident parent] to be [<sup>F18</sup>identified or] traced (where that is necessary);
  - (b) the amount of child support maintenance payable by the [<sup>F2</sup>non-resident parent] to be assessed; and
  - (c) that amount to be recovered from the [<sup>F2</sup>non-resident parent].
- (5) Any person who has applied to the [<sup>F19</sup>Secretary of State] under this section may at any time request [<sup>F19</sup>the Secretary of State] to cease acting under this section.
- (6) It shall be the duty of the [<sup>F20</sup>Secretary of State] to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).
- (7) The obligation to provide information which is imposed by subsection (4)—
- (a) shall not apply in such circumstances as may be prescribed; and
  - (b) may, in such circumstances as may be prescribed, be waived by the [<sup>F21</sup>Secretary of State].
- (8) The Secretary of State may by regulations make such incidental, supplemental or transitional provision as he thinks appropriate with respect to cases in which he is requested to cease to act under this section.

[<sup>F23</sup>(10) No application may be made at any time under this section with respect to a qualifying child or any qualifying children if—

- (a) there is in force a written maintenance agreement made before 5th April 1993, or a maintenance order [<sup>F24</sup>made before a prescribed date], in respect of that child or those children and the person who is, at that time, the [<sup>F2</sup>non-resident parent]; or

[<sup>F25</sup>(aa) a maintenance order made on or after the date prescribed for the purposes of paragraph (a) is in force in respect of them, but has been so for less than the period of one year beginning with the date on which it was made; or]

## **5 Child support maintenance: supplemental provisions.**

- (1) Where—
  - (a) there is more than one person with care of a qualifying child; and
  - (b) one or more, but not all, of them have parental responsibility for <sup>F29</sup>... the child; no application may be made for a [<sup>F3</sup>maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for <sup>F29</sup>... the child.
- (2) Where more than one application for a [<sup>F3</sup>maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.
- (3) The Secretary of State may by regulations make provision as to which of two or more applications for a [<sup>F3</sup>maintenance calculation] with respect to the same child is to be proceeded with.

## 7 Right of child in Scotland to apply for [F<sup>1</sup> calculation].

- (1) A qualifying child who has attained the age of 12 years and who is habitually resident in Scotland may apply to the [F<sup>31</sup>Secretary of State] for a [F<sup>3</sup>maintenance calculation] to be made with respect to him if—
  - (a) no such application has been made by a person who is, with respect to that child, a person with care or [F<sup>2</sup>a non-resident parent]; F<sup>32</sup> ...
  - F<sup>32</sup>(b) .....
- (2) An application made under subsection (1) shall authorise the [F<sup>31</sup>Secretary of State] to make a [F<sup>3</sup>maintenance calculation] with respect to any other children of the [F<sup>2</sup>non-resident parent] who are qualifying children in the care of the same person as the child making the application.
- (3) Where a [F<sup>3</sup>maintenance calculation] has been made in response to an application under this section the [F<sup>33</sup>Secretary of State] may, if the [F<sup>34</sup>person with care or] the child concerned applies to [F<sup>33</sup>the Secretary of State] under this subsection, arrange for—
  - (a) the collection of the child support maintenance payable in accordance with the [F<sup>1</sup>calculation];
  - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [F<sup>1</sup>calculation].
- [F<sup>35</sup>(3A) The [F<sup>36</sup>Secretary of State] may only make arrangements under subsection (3)(a) if—
  - (a) the non-resident parent agrees to the arrangements, or
  - (b) the [F<sup>36</sup>Secretary of State] is satisfied that without the arrangements child support maintenance is unlikely to be paid in accordance with the calculation.]

## 8 Role of the courts with respect to maintenance for children.

- (1) This subsection applies in any case where [<sup>F47</sup>the [<sup>F48</sup>Secretary of State]] would have jurisdiction to make a [<sup>F3</sup>maintenance calculation] with respect to a qualifying child and [<sup>F2</sup>a non-resident parent] of his on an application duly made <sup>F49</sup>... by a person entitled to apply for such [<sup>F1</sup>a calculation] with respect to that child.
- (2) Subsection (1) applies even though the circumstances of the case are such that [<sup>F47</sup>the [<sup>F48</sup>Secretary of State]] would not make [<sup>F1</sup>a calculation] if it were applied for.

## **9 Agreements about maintenance.**

**10 Relationship between maintenance [<sup>F1</sup>calculations] and certain court orders and related matters.**

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [<sup>F3</sup>maintenance calculation] is made, the order—

## 15 Powers of inspectors.

- [<sup>F100</sup>(1) The [<sup>F101</sup>Secretary of State] may appoint, on such terms as [<sup>F101</sup>the Secretary of State] thinks fit, persons to act as inspectors under this section.
- (2) The function of inspectors is to acquire information which the [<sup>F102</sup>the Secretary of State] needs for any of the purposes of this Act.
- (3) Every inspector is to be given a certificate of his appointment.
- (4) An inspector has power, at any reasonable time and either alone or accompanied by such other persons as he thinks fit, to enter any premises which—
- are liable to inspection under this section; and
  - are premises to which it is reasonable for him to require entry in order that he may exercise his functions under this section,
- and may there make such examination and inquiry as he considers appropriate.
- [<sup>F103</sup>(4ZA) But the power under subsection (4) to enter any premises is exercisable only under the authority of a warrant issued under section 15A if—
- the premises are occupied, and
  - an inspector has applied for admission to the premises for the purposes of exercising the power under that subsection but admission has been refused.]

(4A) Premises liable to inspection under this section are those which are not used wholly as a dwelling house and which the inspector has reasonable grounds for suspecting are—

    - premises at which a non-resident parent is or has been employed;
    - premises at which a non-resident parent carries out, or has carried out, a trade, profession, vocation or business;
    - premises at which there is information held by a person (“A”) whom the inspector has reasonable grounds for suspecting has information about a non-resident parent acquired in the course of A’s own trade, profession, vocation or business.]

(5) An inspector exercising his powers may question any person aged 18 or over whom he finds on the premises.

- (8) On applying for admission to any premises in the exercise of his powers, an inspector shall, if so required, produce his certificate.

- (a) intentionally delays or obstructs any inspector exercising his powers; or
  - (b) without reasonable excuse, refuses or neglects to answer any question or furnish any information or to produce any document when required to do so under this section,
- he shall be guilty of an offence and liable on summary conviction to a fine not exceeding level 3 on the standard scale.

- (1) The appropriate court may issue a warrant authorising entry to premises if, on an application made by an inspector, the court is satisfied that—
  - (a) any of the conditions in subsection (2) is met, and
  - (b) each of the conditions in subsection (3) is met.
- (2) The conditions referred to in subsection (1)(a) are—
  - (a) that, having attempted to exercise the power conferred by section 15(4), an inspector has been refused entry to the premises,
  - (b) that it is not practicable to communicate with any person entitled to grant entry to the premises, or
  - (c) that entry to the premises is unlikely to be granted unless a warrant is produced.
- (3) The conditions referred to in subsection (1)(b) are—
  - (a) that the premises are liable to inspection under section 15 (see section 15(4A)),
  - (b) that the premises are premises to which it is reasonable for an inspector to require entry in order to exercise the inspector's functions under section 15,
  - (c) that the premises are occupied, and
  - (d) that the occupier has been given at least 21 days' notice of intention to apply for a warrant.
- (4) An application for a warrant must be supported—
  - (a) in England and Wales, by an information in writing;
  - (b) in Scotland, by evidence on oath.
- (5) The warrant must specify the premises to which the warrant relates.
- (6) A warrant authorises an inspector's entry to the specified premises, at any reasonable time and either alone or accompanied by such persons as the inspector thinks fit, for the purpose of exercising the inspector's functions under section 15.

## 28ZC Restrictions on liability in certain cases of error

- (1) Subject to subsection (2), this section applies where—

- an application for a variation is made by the non-resident parent; and
  - the <sup>F271</sup>Secretary of State] makes an interim maintenance decision,
- the <sup>F271</sup>Secretary of State] may also, if <sup>F271</sup>the Secretary of State] has completed <sup>F271</sup>a] preliminary consideration (under section 28B) of the application for a variation and has not rejected it under that section, impose on the non-resident parent one of the conditions mentioned in subsection (2) (a “regular payments condition”).

#### **29 Collection of child support maintenance.**

- (1) The [<sup>F319</sup>Secretary of State] may [<sup>F320</sup>(subject to section 4(2A) and 7(3A))] arrange for the collection of any child support maintenance payable in accordance with a [<sup>F3</sup>maintenance calculation] where—

## 30 Collection and enforcement of other forms of maintenance.

**31 Deduction from earnings orders.**

- (1) This section applies where any person (“the liable person”) is liable to make payments of child support maintenance.
- (2) The [<sup>F332</sup>Secretary of State] may make an order (“a deduction from earnings order”) against a liable person to secure the payment of any amount due under the [<sup>F3</sup>maintenance calculation] in question.
- (3) A deduction from earnings order may be made so as to secure the payment of—
  - (a) arrears of child support maintenance payable under the [<sup>F1</sup>calculation];
  - (b) amounts of child support maintenance which will become due under the [<sup>F1</sup>calculation]; or
  - (c) both such arrears and such future amounts.
- (4) A deduction from earnings order—
  - (a) shall be expressed to be directed at a person (“the employer”) who has the liable person in his employment; and
  - (b) shall have effect from such date as may be specified in the order.
- (5) A deduction from earnings order shall operate as an instruction to the employer to—
  - (a) make deductions from the liable person’s earnings; and
  - (b) pay the amounts deducted to the [<sup>F333</sup>Secretary of State].
- (6) The [<sup>F334</sup>Secretary of State] shall serve a copy of any deduction from earnings order [<sup>F334</sup>made] under this section on—
  - (a) the person who appears to the [<sup>F334</sup>Secretary of State] to have the liable person in question in his employment; and
  - (b) the liable person.
- (7) Where—
  - (a) a deduction from earnings order has been made; and
  - (b) a copy of the order has been served on the liable person’s employer,it shall be the duty of that employer to comply with the order; but he shall not be under any liability for non-compliance before the end of the period of 7 days beginning with the date on which the copy was served on him.

## 32 Regulations about deduction from earnings orders.

- (1) The Secretary of State may by regulations make provision with respect to deduction from earnings orders.
- (2) The regulations may, in particular, make provision—
  - (a) as to the circumstances in which one person is to be treated as employed by another;
  - (b) requiring any deduction from earnings under an order to be made in the prescribed manner;
  - <sup>F335</sup>(bb) for the amount or amounts which are to be deducted from the liable person's earnings not to exceed a prescribed proportion of his earnings (as determined by the employer);]
  - (c) requiring an order to specify the amount or amounts to which the order relates and the amount or amounts which are to be deducted from the liable person's earnings in order to meet his liabilities under the <sup>F3</sup>maintenance calculation] in question;
  - (d) requiring the intervals between deductions to be made under an order to be specified in the order;
  - (e) as to the payment of sums deducted under an order to the <sup>F336</sup>Secretary of State];
  - (f) allowing the person who deducts and pays any amount under an order to deduct from the liable person's earnings a prescribed sum towards his administrative costs;

- (g) with respect to the notification to be given to the liable person of amounts deducted, and amounts paid, under the order;
  - (h) requiring any person on whom a copy of an order is served to notify the [<sup>F336</sup>Secretary of State] in the prescribed manner and within a prescribed period if he does not have the liable person in his employment or if the liable person ceases to be in his employment;
  - (i) as to the operation of an order where the liable person is in the employment of the Crown;
  - (j) for the variation of orders;
  - (k) similar to that made by section 31(7), in relation to any variation of an order;

- (4) The regulations may include provision with respect to the priority as between a deduction from earnings order and—
- (a) any other deduction from earnings order;
  - (b) any order under any other enactment relating to England and Wales which provides for deductions from the liable person's earnings;
  - (c) any diligence against earnings.
- (5) The regulations may include a provision that a liable person may appeal to a magistrates' court (or in Scotland to the sheriff) if he is aggrieved by the making of a deduction from earnings order against him, or by the terms of any such order, or there is a dispute as to whether payments constitute earnings or as to any other prescribed matter relating to the order.

## 32B Orders under section 32A: joint accounts

- (1) Before making an order under section 32A in respect of a joint account the [<sup>F343</sup>Secretary of State] shall offer each of the account-holders an opportunity to make representations about—

### 32D Orders under section 32A: offences

### 32J Regulations about orders under section 32E or 32F

### 32K Lump sum deduction orders: offences

### [<sup>F357</sup>32L Orders preventing avoidance

- (1) The [<sup>F358</sup>Secretary of State] may apply to the court, on the grounds that a person—
  - (a) has failed to pay an amount of child support maintenance, and
  - (b) with the intention of avoiding payment of child support maintenance, is about to make a disposition or to transfer out of the jurisdiction or otherwise deal with any property,

### 39 Liability orders: enforcement throughout United Kingdom.

- (1) The Secretary of State may by regulations provide for—

### 39C Period for which orders under section 39B are to have effect

- (1) The Secretary of State may by regulations make provision for the payment to [<sup>F411</sup>the [<sup>F412</sup>Secretary of State]] by non-resident parents who are in arrears with payments of child support maintenance of penalty payments determined in accordance with the regulations.

- (1) This section applies where it appears to the [<sup>F416</sup>Secretary of State] that [<sup>F2</sup>a non-resident parent] has made a payment by way of child support maintenance which amounts to an overpayment by him of that maintenance and that—
  - (a) it would not be possible for the [<sup>F2</sup>non-resident parent] to recover the amount of the overpayment by way of an adjustment of the amount payable under a [<sup>F3</sup>maintenance calculation]; or
  - (b) it would be inappropriate to rely on an adjustment of the amount payable under a [<sup>F3</sup>maintenance calculation] as the means of enabling the [<sup>F2</sup>non-resident parent] to recover the amount of the overpayment.

[ This section also applies where the non-resident parent has made a voluntary payment <sup>F417</sup>(1A) and it appears to the [<sup>F418</sup>Secretary of State]—

- (a) that he is not liable to pay child support maintenance; or
  - (b) that he is liable, but some or all of the payment amounts to an overpayment, and, in a case falling within paragraph (b), it also appears to [<sup>F418</sup>the Secretary of State] that subsection (1)(a) or (b) applies.]

## 51 Supplementary powers to make regulations.

### 57 Application to Crown.

- (1) The power of the Secretary of State to make regulations under section 14 requiring prescribed persons to furnish information may be exercised so as to require information to be furnished by persons employed in the service of the Crown or otherwise in the discharge of Crown functions.

## **58 Short title, commencement and extent, etc.**

- (4) An order under subsection (2) may make such supplemental, incidental or transitional provision as appears to the person making the order to be necessary or expedient in connection with the provisions brought into force by the order, including such adaptations or modifications of—
  - (a) the provisions so brought into force;
  - (b) any provisions of this Act then in force; or
  - (c) any provision of any other enactment,as appear to him to be necessary or expedient.
- (5) Different provision may be made by virtue of subsection (4) with respect to different periods.
- (6) Any provision made by virtue of subsection (4) may, in particular, include provision for—
  - (a) the enforcement of a [F<sup>3</sup> maintenance calculation] (including the collection of sums payable under the [F<sup>1</sup> calculation]) as if the [F<sup>1</sup> calculation] were a court order of a prescribed kind;
  - (b) the registration of maintenance [F<sup>1</sup> calculations] with the appropriate court in connection with any provision of a kind mentioned in paragraph (a);
  - (c) the variation, on application made to a court, of the provisions of a [F<sup>3</sup> maintenance calculation] relating to the method of making payments fixed by the [F<sup>1</sup> calculation] or the intervals at which such payments are to be made;

  - (d) a person has unreasonably reduced the income which is taken into account in such a calculation.

## PART II

### REGULATORY CONTROLS

- 5 (1) The Secretary of State may by regulations make provision with respect to the variations from the usual rules for calculating maintenance which may be allowed when a variation is agreed.
- (2) No variations may be made other than those which are permitted by the regulations.
- (3) Regulations under this paragraph may, in particular, make provision for a variation to result in—
- (a) a person's being treated as having more, or less, income than would be taken into account without the variation in a calculation under Part I of Schedule 1;
  - (b) a person's being treated as liable to pay a higher, or a lower, amount of child support maintenance than would result without the variation from a calculation under that Part.
- (4) Regulations may provide for the amount of any special expenses to be taken into account in a case falling within paragraph 2, for the purposes of a variation, not to exceed such amount as may be prescribed or as may be determined in accordance with the regulations.
- (5) Any regulations under this paragraph may in particular make different provision with respect to different levels of income.
- 6 The Secretary of State may by regulations provide for the application, in connection with child support maintenance payable following a variation, of paragraph 7(2) to (7) of Schedule 1 (subject to any prescribed modifications).]
