81 **Directions.** **E+W**

- (1) In exercising their functions under this Part of this Act, [^{F5}the HEFCW] shall comply with any directions under this section, and such directions shall be contained in an order made by the Secretary of State.
- (2) The Secretary of State may give general directions to [^{F6}the HEFCW] about the exercise of their functions.
- (3) If it appears to the Secretary of State that the financial affairs of any institution within the higher education sector have been or are being mismanaged he may, after consulting [^{F7}the HEFCW] and the institution, give such directions to [^{F7}the HEFCW] about the provision of financial support in respect of the activities carried on by the institution as he considers are necessary or expedient by reason of the mismanagement.
