PERSONS DISREGARDED FOR PURPOSES OF DISCOUNT

Patients in homes in England and Wales

- 7 (1) A person shall be disregarded for the purposes of discount on a particular day if on the day—
 - (a) he has his sole or main residence in a [FI care home, independent hospital] or hostel in England and Wales; and
 - (b) he is receiving care or treatment (or both) in the home $[F^2]$, hospital] or hostel.
 - [F3(2) In this paragraph—

"care home" means—

- (a) a care home within the meaning of the Care Standards Act 2000; or
- (b) a building or part of a building in which residential accommodation is provided under section 21 of the MINational Assistance Act 1948;

"hostel" means anything which falls within any definition of hostel for the time being prescribed by order made by the Secretary of State under this sub-paragraph;

"independent hospital" has the same meaning as in the Care Standards Act 2000.]

(3) The Secretary of State may by order substitute another definition for any definition of [F4"care home" or "independent hospital"] for the time being effective for the purposes of this paragraph.
