LIMITATION OF COUNCIL TAX AND PRECEPTS

- (1) This section applies if—
 - (a) the period mentioned in section 52M(8) above ends without an authority designated under section 52M above informing the [^{F2}Welsh Ministers] by notice in writing under paragraph (a) or (b) of section 52M(8), or
 - (b) the period mentioned in section 52P(8) above ends without an authority designated under section 52P above informing the [^{F3}Welsh Ministers] by notice in writing under paragraph (a) or (b) of section 52P(8).
- (2) As soon as is reasonably practicable after the period ends the [^{F4}Welsh Ministers] shall make an order stating the amount which the amount calculated by the authority as its budget requirement for the year is not to exceed; and the amount stated shall be that stated in the notice under section 52M(4)(b) or 52P(4)(b) above (as the case may be).
- (3) An order under this section—
 - (a) shall not be made unless a draft of it has been laid before and approved by resolution of the [^{F5}National Assembly for Wales];
 - (b) may relate to two or more authorities.
