#### CONTRIBUTORY BENEFITS

[FI] Bereavement benefits: deaths before the day on which section 29 of the Pensions Act (Northern Ireland) 2015 comes into operation]

# [F139A Widowed parent's allowance.

[F2(1) This section applies where—

- (a) a person's spouse or civil partner has died before the day on which section 29 of the Pensions Act (Northern Ireland) 2015 comes into operation (but see subsection (1A)),
- (b) the person has not married or formed a civil partnership after the death but before that day, and
- (c) the person is under pensionable age on that day.]

[ This section does not apply in cases where a woman's husband has died before 9 April <sup>F2</sup>(1A) 2001.]

- (2) The surviving spouse [F3 or civil partner] shall be entitled to a widowed parent's allowance at the rate determined in accordance with section 39C below if the deceased spouse [F3 or civil partner] satisfied the contribution conditions for a widowed parent's allowance specified in Schedule 3, Part I, paragraph 5 and—
  - (a) the surviving spouse [F3 or civil partner] is entitled to child benefit in respect of a child [F4 or qualifying young person] falling within subsection (3) below; F5...
  - (b) the surviving spouse is a woman who either—
    - (i) is pregnant by her late husband, or

- (ii) if she and he were residing together immediately before the time of his death, is pregnant in circumstances falling within section 37(1)(c) above; [F6 or
- (c) the surviving civil partner is a woman who—
  - (i) was residing together with the deceased civil partner immediately before the time of the death, and
  - (ii) is pregnant as the result of being artificially inseminated before that time with the semen of some person, or as a result of the placing in her before that time of an embryo, of an egg in the process of fertilisation, or of sperm and eggs].
- (3) A child [F7 or qualifying young person] falls within this subsection if F8... the child [F9 or qualifying young person] is either—
  - (a) a son or daughter of the surviving spouse [F³ or civil partner] and the deceased spouse [F³ or civil partner]; or
     (b) a child [F¹0 or qualifying young person] in respect of whom the deceased spouse
  - (b) a child [F10 or qualifying young person] in respect of whom the deceased spouse [F3 or civil partner] was immediately before his or her death entitled to child benefit; or
  - (c) if the surviving spouse [F³ or civil partner] and the deceased spouse [F³ or civil partner] were residing together immediately before his or her death, a child [F¹0 or qualifying young person] in respect of whom the surviving spouse [F³ or civil partner] was then entitled to child benefit.
- (4) The surviving spouse shall not be entitled to the allowance for any period after she or he remarries [FII or forms a civil partnership], but, subject to that, the surviving spouse shall continue to be entitled to it for any period throughout which she or he—
  - (a) satisfies the requirements of subsection (2)(a) or (b) above; and
  - (b) is under pensionable age.
- [ The surviving civil partner shall not be entitled to the allowance for any period after F12(4A) she or he forms a subsequent civil partnership or marries, but, subject to that, the surviving civil partner shall continue to be entitled to it for any period throughout which she or he—
  - (a) satisfies the requirements of subsection (2)(a) or (b) above; and
  - (b) is under pensionable age.]
  - (5) A widowed parent's allowance shall not be payable—
    - (a) for any period falling before the day on which the surviving spouse's [F13 or civil partner's] entitlement is to be regarded as commencing by virtue of section 5(1)(1) of the Administration Act; F14...
    - (b) for any period during which the surviving spouse [F3 or civil partner] and a person of the opposite sex to whom she or he is not married are living together as husband and wife; [F15 or
    - (c) for any period during which the surviving spouse or civil partner and a person of the same sex who is not his or her civil partner are living together as if they were civil partners].]
