Importation and exportation restrictions

46 Importation and exportation restrictions. U.K.

(1) In section 1 of the ^{M1}Revenue Act 1898 (prohibition on the importation of advertisements and notices relating to lotteries) as it applies in the United Kingdom, after “importation” there shall be inserted “ from a place outside the British Islands and the member States ”.

(2) That section so far as it applies in the British Islands outside the United Kingdom shall cease to have effect.
