- it is likely, were members of the public to be present during that item, that information furnished in confidence to the committee by the [<sup>F18</sup>the Office of Rail Regulation] or the [<sup>F19</sup>Authority] would be disclosed in breach of the obligation of confidence;
  - [<sup>F17</sup>a Rail Passengers' Committee] have resolved that, by reason of the confidential nature of the item or for other special reasons stated in the resolution, it is desirable in the public interest that the public be excluded;
  - it is likely, were members of the public to be present during that item, that there would be disclosed to them—
    - any matter which relates to the affairs of an individual, or
    - any matter which relates specifically to the affairs of a particular body of persons, whether corporate or unincorporate, [<sup>F20</sup>or
  - the circumstances are such as are specified in, or determined by resolution of a Rail Passengers' Committee in accordance with, an order made by the Secretary of State.]
