##### SPECIFIC PROVISIONS

###### *Modifications in consequence of enactment of Part I of the Social Security Act 1986*

- 17 (1) Regulations may provide that any provision of this Act to which section 154 applies shall have effect subject to such modifications (other than those which may be made by virtue of that section) as the Secretary of State may consider necessary or expedient in consequence of Part I of the <sup>M1</sup>Social Security Act 1986 or any provision of this Act deriving from that Part.
- (2) Regulations may provide that any provision contained in an Act to which this sub-paragraph applies shall have effect subject to such modifications as the Secretary of State may consider necessary or expedient in consequence of the provisions mentioned in sub-paragraph (1) or in consequence of any corresponding enactment extending to Northern Ireland.
- (3) The Acts to which sub-paragraph (2) applies are—
- (a) the <sup>M2</sup>Fire Services Act 1947;
  - (b) the <sup>M3</sup>Sheriffs' Pensions (Scotland) Act 1961;
  - (c) the <sup>M4</sup>Superannuation Act 1972;
  - (d) the <sup>M5</sup>Parliamentary and other Pensions Act 1972;
  - (e) the <sup>M6</sup>Water Act 1973;
  - (f) the <sup>M7</sup>Police Pensions Act 1976;
  - (g) the <sup>M8</sup>Parliamentary Pensions Act 1978;
  - (h) the <sup>M9</sup>Judicial Pensions Act 1981;
  - (i) any Act which relates to the employment of persons by a harbour authority (within the meaning of section 57(1) of the <sup>M10</sup>Harbours Act 1964);
  - (j) the <sup>M11</sup>Judicial Pensions and Retirement Act 1993.
