Imposition and rate of VAT

# 2 Rate of VAT.

- (1) Subject to the following provisions [<sup>F1</sup>and to the provisions of section 29A] of this section <sup>F2</sup>..., VAT shall be charged at the rate of [<sup>F3</sup>20 per cent] and shall be charged—
  - (a) on the supply of goods or services, by reference to the value of the supply as determined under this Act; and
  - (b) on the acquisition of goods from another member State, by reference to the value of the acquisition as determined under this Act; and
  - (c) on the importation of goods from a place outside the member States, by reference to the value of the goods as determined under this Act.

  - (2) The Treasury may by order increase or decrease the rate of VAT for the time being in force [<sup>F6</sup>under this section] by such percentage thereof not exceeding 25 per cent. as may be specified in the order, but any such order [<sup>F7</sup>that has not previously expired or been revoked] shall cease to be in force at the expiration of a period of one year from the date on which it takes effect, unless continued in force by a further order under this subsection.
  - (3) In relation to an order made under subsection (2) above to continue, vary or replace a previous order, the reference in that subsection to the rate for the time being in force [<sup>F6</sup>under this section] is a reference to the rate which would be in force if no order under that subsection had been made.
