Provision of new prisons

113 Provision of new prisons. S

- (1) The [F¹Scottish Ministers] may declare to be a prison—
 - (a) any building or part of a building built or adapted for the purpose; and
 - (b) any floating structure or part of such a structure constructed or adapted for the purpose,whether vested in, or under the control of, the [F¹Scottish Ministers] or any other person.
- (2) Section 106(1) and subsection (1) above are without prejudice to the [F¹Scottish Ministers] powers under the 1989 Act with respect to the provision of prisons.
- (3) A declaration under subsection (1) above—
 - (a) shall have effect for the purposes of the 1989 Act and any other enactment (including an enactment contained in subordinate legislation);
 - (b) shall not be sufficient to vest the legal estate in any building or structure in the [F¹Scottish Ministers]; and
 - (c) may be revoked by the [F¹Scottish Ministers] at any time other than a time when the prison to which it relates is a contracted out prison.

- (4) Nothing in section 36 of the 1989 Act (prison property to be vested in the [^{F1}Scottish Ministers]) shall require the legal estate in—
- (a) any prison provided under a contract entered into under section 106(1) above;
 - (b) any prison declared to be such under subsection (1) above and not vested in the [^{F1}Scottish Ministers]; or
 - (c) any heritable or moveable property belonging to any prison mentioned in paragraph (a) or (b) above,
- to be vested in the [^{F1}Scottish Ministers].
