CHAPTER 1 **S**

LOCAL GOVERNMENT AREAS, AUTHORITIES AND ELECTIONS

5 Elections and term of office of councillors. **S**

- (1) ^{F1}
- (2) Notwithstanding the provisions of section 43 of that Act of 1983 (day of ordinary local elections in Scotland), the first ordinary election of councillors for each council other than the councils of Orkney Islands, Shetland Islands and Western Isles shall take place on 6th April 1995.
- (3) The second ordinary election of councillors shall take place in 1999, and ordinary elections shall take place [^{F2}thereafter in the years in which, under section 2(2) of the Scotland Act 1998 (c.46), polls at ordinary general elections for membership of the Scottish Parliament fall to be held].
- (4) Councillors shall retire on the day [^{F3}on which the poll is held at] the ordinary election next following the date on which they were elected.
