## CHAPTER I

#### PARTICULAR TYPES OF EMPLOYMENT

Excluded classes of employment

## 200 Police officers.

- (1) Sections 8 to 10, Part III [F1, Part IVA], sections F2..., 45, [F345A,] 47 [F4, 47B], [F547C,]50 [F6 to 57B] and 61 to 63, Parts VII and VIII, sections 92 and 93 [F7 and], Part X [F8 (except sections 100 and 134A and the other provisions of that Part so far as relating to the right not to be unfairly dismissed in a case where the dismissal is unfair by virtue of section 100)]. . .do not apply to employment under a contract of employment in police service or to persons engaged in such employment.
- (2) In subsection (1) "police service" means—
  - (a) service as a member of a constabulary maintained by virtue of an enactment, or
  - (b) subject to section 126 of the MICriminal Justice and Public Order Act 1994 (prison staff not to be regarded as in police service), service in any other capacity by virtue of which a person has the powers or privileges of a constable.
