## 312 Meaning of “special educational needs” and “special educational provision” etc. **E+W**

- (1) A child [<sup>F3</sup>in the area of a local authority in Wales] has “special educational needs” for the purposes of this Act if he has a learning difficulty which calls for special educational provision to be made for him.
- (2) Subject to [<sup>F4</sup>subsections (3) and (3A)] a child [<sup>F5</sup>in the area of a local authority in Wales] has a “learning difficulty” for the purposes of this Act if—
  - (a) he has a significantly greater difficulty in learning than the majority of children of his age,
  - (b) he has a disability which either prevents or hinders him from making use of educational facilities of a kind generally provided for children of his age in schools within the area of the [<sup>F6</sup>local authority] , or
  - (c) he is under [<sup>F7</sup>compulsory school age] and is, or would be if special educational provision were not made for him, likely to fall within paragraph (a) or (b) when of <sup>F8</sup>. . . that age.
- (3) A child is not to be taken as having a learning difficulty solely because the language (or form of the language) in which he is, or will be, taught is different from a language (or form of a language) which has at any time been spoken in his home.

[<sup>F9</sup>(3A) Subsection (2) does not apply—

- (a) for the purposes of sections <sup>F10</sup>... , 15A [<sup>F11</sup>and 15B], or
  - (b) for the purposes of sections 18A and 562H (except for the purpose of [<sup>F12</sup>a local authority in Wales] determining, for the purposes of those sections, whether a child has special educational needs).]
- (4) In this Act “special educational provision” means—
    - (a) in relation to a child who has attained the age of two, educational provision which is additional to, or otherwise different from, the educational provision made generally for children of his age in schools maintained by the [<sup>F6</sup>local authority] (other than special schools) <sup>F13</sup>. . . , and
    - (b) in relation to a child under that age, educational provision of any kind.

“child” includes any person who has not attained the age of 19 and is a registered pupil at a school;

### [<sup>F15</sup>312A] Children subject to detention **E+W**

- (1) No provision of, or made under, this Part applies in relation to a child who is subject to a detention order and detained in relevant youth accommodation.
- (2) The following provisions of this section apply where a child who has been subject to a detention order is released having, immediately before release, been detained in relevant youth accommodation.
- (3) Subject to subsection (6), a statement which was maintained for the child by a local authority under section 324 immediately before the beginning of the detention is, from the child's release, to be treated as being maintained by that authority under section 324.
- (4) In subsection (3) “the beginning of the detention” means—
  - (a) the beginning of the period of detention in relevant youth accommodation, or
  - (b) where that period is part of a continuous period, comprising periods of detention in relevant youth accommodation and in other accommodation, the beginning of that continuous period.

**313 Code of Practice. E+W**

- (1) The [<sup>F16</sup>Welsh Ministers] shall issue, and may from time to time revise, a code of practice giving practical guidance in respect of the discharge by [<sup>F17</sup>local authorities] and the governing bodies of [<sup>F18</sup>maintained schools][<sup>F19</sup> and maintained nursery schools ] of their functions under this Part.

## 314 Making and approval of code. **E+W**

- (1) Where the [<sup>F26</sup>Welsh Ministers propose] to issue or revise a code of practice, [<sup>F27</sup>they] shall prepare a draft of the code (or revised code).
- (2) The [<sup>F28</sup>Welsh Ministers] shall consult such persons about the draft as [<sup>F29</sup>they think] fit and shall consider any representations made by [<sup>F30</sup>those persons].
- [<sup>F31</sup>(3) If the Welsh Ministers determine to proceed with the draft (either in its original form or with such modifications as they think fit) they shall lay it before the National Assembly for Wales.]

- (2) If no statement is maintained under section 324 for the child, he must be educated in a mainstream school.
- (3) If a statement is maintained under section 324 for the child, he must be educated in a mainstream school unless that is incompatible with—
  - (a) the wishes of his parent, or
  - (b) the provision of efficient education for other children.

#### [<sup>F38</sup>316A Education otherwise than in mainstream schools **E+W**

- (1) Section 316 does not prevent a child from being educated in—
- (a) an independent school which is not a mainstream school, or
  - (b) a school approved under section 342,
- if the cost is met otherwise than by a [<sup>F6</sup>local authority].
- (2) Section 316(2) does not require a child to be educated in a mainstream school during any period in which—
- (a) he is admitted to a special school for the purposes of an assessment under section 323 of his educational needs and his admission to that school is with the agreement of—
    - (i) the [<sup>F6</sup>local authority],
    - [<sup>F39</sup>(ii) the governing body of the school or, if the school is in England, its head teacher,]
    - (iii) his parent, and

- (d) he is admitted to a community or foundation special school which is established in a hospital.
- (3) Section 316 does not affect the operation of—
- (a) section 348, or
  - (b) paragraph 3 of Schedule 27.
- (4) If a [<sup>F6</sup>local authority] decide—
- (a) to make a statement for a child under section 324, but
  - (b) not to name in the statement the school for which a parent has expressed a preference under paragraph 3 of Schedule 27,
- they shall, in making the statement, comply with section 316(3).
- (5) A [<sup>F6</sup>local authority] may, in relation to their mainstream schools taken as a whole, rely on the exception in section 316(3)(b) only if they show that there are no reasonable steps that they could take to prevent the incompatibility.
- (6) An authority in relation to a particular mainstream school may rely on the exception in section 316(3)(b) only if it shows that there are no reasonable steps that it or another authority in relation to the school could take to prevent the incompatibility.

### 320 Provision outside England and Wales for certain children. **E+W**

#### **321 General duty of <sup>F6</sup>local authority] towards children for whom they are responsible. **E+W****

### 323 Assessment of educational needs. **E+W**

- (1) Where a [<sup>F6</sup>local authority] are of the opinion that a child for whom they are responsible falls, or probably falls, within subsection (2), they shall serve a notice on the child's parent informing him—
- that they [<sup>F91</sup>are considering whether] to make an assessment of the child's educational needs,

### 324 Statement of special educational needs. **E+W**

- (1) If, in the light of an assessment under section 323 of any child's educational needs and of any representations made by the child's parent in pursuance of Schedule 27, it is necessary for the <sup>F6</sup>local authority to determine the special educational provision which any learning difficulty he may have calls for, the authority shall make and maintain a statement of his special educational needs.
  - (2) The statement shall be in such form and contain such information as may be prescribed.
  - (3) In particular, the statement shall—
    - (a) give details of the authority's assessment of the child's special educational needs, and

### 325 Appeal against decision not to make statement. **E+W**

### 326 Appeal against contents of statement. **E+W**

(b) either the name of the school is specified in a statement in respect of the child under section 324 or the [<sup>F6</sup>local authority] are satisfied—

(i) that his interests require the necessary special educational provision to be made for him at a school which is not a maintained school, and

(ii) that it is appropriate for the child to be provided with education at the particular school.

(2) Where this section applies, the [<sup>F6</sup>local authority] shall pay the whole of the fees payable in respect of the education provided for the child at the school, and if—

(a) board and lodging are provided for him at the school, and

(b) the authority are satisfied that the necessary special educational provision cannot be provided for him at the school unless the board and lodging are also provided,

the authority shall pay the whole of the fees payable in respect of the board and lodging.

#### **349 Variation of trust deeds etc. by order. E+W**

- (1) [<sup>F263</sup>The appropriate national authority] may by order make such modifications of any trust deed or other instrument relating to a school as, after consultation with the governing body or other proprietor of the school, appear to [<sup>F264</sup>it] to be necessary to enable the governing body or proprietor to meet any requirement imposed by [<sup>F265</sup>— (a)] regulations under section 342 <sup>F266</sup>.... [<sup>F265</sup>, or “(b) Academy arrangements.”]
