**[<sup>F4</sup>483A City colleges and academies: special educational needs.**

- (1) This section applies in relation to any child falling within subsection (2) if the condition in subsection (3) is satisfied.
- (2) A child falls within this subsection if—
  - (a) he is a child for whom a statement is maintained under section 324, and
  - (b) he attends (or proposes to attend) a school which is a city technology college, a city college for the technology of the arts or [<sup>F5</sup>an Academy] .
- (3) The condition in this subsection is satisfied if—
  - [<sup>F6</sup>(a) the statement is maintained by a local authority in England, or
  - (b) the statement is maintained by a local authority in Wales and the Welsh Ministers consent to the child being educated at the school.]
- (4) [<sup>F7</sup>The appropriate national authority] may by regulations make provision for securing that arrangements are made—
  - (a) for making the special educational provision specified in the statement;
  - (b) for making any non-educational provision specified in the statement.
- (5) Regulations under subsection (4) may require or authorise a [<sup>F8</sup>local authority]—
  - (a) to make payments to the school in respect of the child, or
  - (b) to provide any other assistance to the school in respect of the child.
- (6) No condition or requirement imposed by virtue of section 482(4)(a) is to prevent a [<sup>F8</sup>local authority] making payments or providing assistance by virtue of subsection (5).

[ In subsection (4) “the appropriate national authority” means—

- <sup>F9</sup>(6A) (a) in relation to a school in England, the Secretary of State;
- (b) in relation to a school in Wales, the Welsh Ministers.]

- (7) [<sup>F10</sup>This section does not apply to schools in Wales.]]
