53 Stamp duty.

- (1) Subject to subsection (2), stamp duty shall not be chargeable in respect of any transfer effected by virtue of section 30 or 34.
- (2) No instrument (other than a statutory instrument) made or executed in pursuance of either of the provisions mentioned in subsection (1) shall be treated as duly stamped unless it is stamped with the duty to which it would, but for this section (and, if applicable, section 129 of the MIFinance Act 1982), be liable or it has, in accordance with the provisions of section 12 of the MIFinance Act 1891, been stamped with a particular stamp denoting that it is not chargeable with any duty or that it has been duly stamped.

54 Orders and regulations.

(1) Any power of the Secretary of State to make orders or regulations under this Act, except an order u.nder section 25 or 31, shall be exercised by statutory instrument.

56 Construction.

- (1) In this Act—
