7 Short title, commencement and extent.

- (1) This Act may be cited as the Education (Schools) Act 1997.
- (2) This Act shall be included in the list of Education Acts set out in section 578 of the Education Act 1996.

(3) In this Act—

- (a) the following provisions shall come into force on 1st September 1997 sections 1 and 2,
 ^{F2}..., and
 - Part I of the Schedule and section 6(3) so far as relating thereto;
- (b) the following provisions shall come into force on such day as the Secretary of State may appoint by order made by statutory instrument—section 5(2), and

Part II of the Schedule and section 6(3) so far as relating thereto;

and the other provisions of this Act come into force on the day on which it is passed.

(4) In this Act—

- (a) the following provisions extend to England and Wales only—sections 1 to 4,
 section 6 ^{F3}... (2), and
 Part I of the Schedule and section 6(3) so far as relating thereto;
- (b) the following provisions extend to Scotland only section 5, and
 Part II of the Schedule and easting (2) of a section 1.

Part II of the Schedule and section 6(3) so far as relating thereto;

and this section extends to England and Wales and Scotland.
