# 5 Procedure in relation to jurisdiction under sections 2 and 3. U.K.

# 6 Appointment of person to represent the appellant's interests. U.K.

  - (a) at least one holds or has held high judicial office (within the meaning of the <sup>M4</sup>Appellate Jurisdiction Act 1876), and
  - (b) at least one is or has been—
