CHAPTER I S

LISTING OF SPECIAL BUILDINGS

1 Listing of buildings of special architectural or historic interest. S

- (1) For the purposes of this Act and with a view to the guidance of planning authorities in the performance of their functions under this Act in relation to buildings of special architectural or historic interest, [F1Historic Environment Scotland] shall compile lists of such buildings or approve, with or without modifications, such lists compiled by other persons or bodies of persons, and may amend any list so compiled or approved.
- (2) In considering whether to include a building in a list compiled or approved under this section, [F2Historic Environment Scotland] may take into account not only the building itself but also
 - any respect in which its exterior contributes to the architectural or historic interest of any group of buildings of which it forms part, and
 - the desirability of preserving, on the ground of its architectural or historic interest, any feature of the building consisting of a man-made object or structure fixed to the building or forming part of the land and comprised within the curtilage of the building.
- (3) Before compiling or approving, with or without modifications, any list under this section or amending any such list [F3Historic Environment Scotland] shall consult such persons or bodies of persons as appear to [F4it] appropriate as having special knowledge of, or interest in, buildings of architectural or historic interest.
- (4) In this Act "listed building" means a building which is for the time being included in a list compiled or approved by [F5Historic Environment Scotland] under this section; and, for the purposes of this Act, the following shall [F6, subject to subsection (4A),] be treated as part of the building
 - any object or structure fixed to the building, and
 - any object or structure within the curtilage of the building which, though not fixed to the building, forms part of the land and has done so since before 1st July 1948.
- [F7(4A) In a list compiled or approved under this section, an entry for a building may provide
 - that an object or structure mentioned in subsection (4)(a) or (b) is not to be treated as part of the building for the purposes of this Act,
 - that any part or feature of the building is not of special architectural or historic (b) interest.]

 - (b) any other loss or damage (not being loss or damage consisting of depreciation of the value of an interest in land) arising out of anything done or omitted to be done before the grant of that consent.
- (4) For the purposes of this section, expenditure incurred in the preparation of plans for the purposes of any works, or upon other similar matters preparatory to any works, shall be taken to be included in the expenditure incurred in carrying out those works.

28 Purchase notice on refusal or conditional grant of listed building consent. S

 - (a) listed building consent in respect of a building is refused or is granted subject to conditions, or is revoked or modified by an order under section 21 or 24, and
 - (b) any owner or lessee of the building claims that—
 - (i) the conditions mentioned in subsection (2) are satisfied with respect to it and any land comprising the building, or contiguous or adjacent to it, and owned or occupied with it, and
 - (ii) the conditions mentioned in subsection (3) are satisfied with respect to that land.



 - as if references in it to the Minister of Transport and to the enactments (b) specified in section 1(1)(b) of that Act included respectively references to the Secretary of State and to this section.
- (4) Any person having an interest in a building which it is proposed to acquire compulsorily under this section may, within 28 days after the service of the notice required to be served under paragraph 3(b) of Schedule 1 to that Act of 1947, apply to the sheriff for an order prohibiting further proceedings on the compulsory purchase
- (5) If on an application under subsection (4) the sheriff is satisfied that reasonable steps have been taken for properly preserving the building, he shall make an order accordingly.
- (6) Any person aggrieved by the decision of the sheriff on an application under subsection (4) may appeal against the decision to the Court of Session, but only on a question of law.

43 Repairs notice as preliminary to acquisition under section 42. S

- (1) The compulsory purchase of a building under section 42 shall not be started by the planning authority or by the Secretary of State unless at least 2 months previously the authority or, as the case may be, the Secretary of State has served on the owner of the building a notice under this section (in this section referred to as a "repairs notice")—

50A Liability of owner and successors for expenses of works executed under section 49 S

- (1) An owner of a listed building who is liable for expenses under section 50(2) does not, by virtue only of ceasing to be such an owner, cease to be liable for those expenses.
- (2) Subject to subsection (3), where a person becomes an owner of a listed building (any such person being referred to in this section as a "new owner") that person is severally liable with any former owner of the building for any expenses for which the former owner is liable under section 50(2).

Damage to listed buildings

53 Acts causing or likely to result in damage to listed buildings. S

 - (d) make different provision with respect to works of different descriptions or according to the extent of the works;
 - (e) make such consequential adaptations or modifications of the operation of any other provision of this Act or the principal Act, or of any instrument made under either of those Acts, as appear to the Secretary of State to be appropriate.

- 4 (1) Any listed building enforcement notice served by the planning authority while the building preservation notice was in force shall cease to have effect.
 - (2) Any proceedings on it under sections 34 to 37 shall lapse.
 - (3) Notwithstanding sub-paragraph (1), section 38(1) and (2) shall continue to have effect as respects any expenses incurred by the planning authority, owner, lessee or occupier as mentioned in that section and with respect to any sums paid on account of such expenses.
