## 1998 CHAPTER 29

### PART VI **U.K.**

#### MISCELLANEOUS AND GENERAL

##### *Information provided to Commissioner or Tribunal*

#### 58 Disclosure of information. **U.K.**

No enactment or rule of law prohibiting or restricting the disclosure of information shall preclude a person from furnishing the Commissioner or the Tribunal with any information necessary for the discharge of their functions under this Act [<sup>F1</sup>or the Freedom of Information Act 2000].

#### 59 Confidentiality of information. **U.K.**

(1) No person who is or has been the Commissioner, a member of the Commissioner's staff or an agent of the Commissioner shall disclose any information which—

- (a) has been obtained by, or furnished to, the Commissioner under or for the purposes of [<sup>F2</sup>the information Acts],
- (b) relates to an identified or identifiable individual or business, and

- (c) is not at the time of the disclosure, and has not previously been, available to the public from other sources,  
unless the disclosure is made with lawful authority.
- (2) For the purposes of subsection (1) a disclosure of information is made with lawful authority only if, and to the extent that—
- (a) the disclosure is made with the consent of the individual or of the person for the time being carrying on the business,
  - (b) the information was provided for the purpose of its being made available to the public (in whatever manner) under any provision of [<sup>F2</sup>the information Acts],
  - (c) the disclosure is made for the purposes of, and is necessary for, the discharge of—
    - (i) any functions under [<sup>F2</sup>the information Acts], or
    - (ii) any Community obligation,
  - (d) the disclosure is made for the purposes of any proceedings, whether criminal or civil and whether arising under, or by virtue of, [<sup>F2</sup>the information Acts] or otherwise, or
  - (e) having regard to the rights and freedoms or legitimate interests of any person, the disclosure is necessary in the public interest.
- (3) Any person who knowingly or recklessly discloses information in contravention of subsection (1) is guilty of an offence.

[<sup>F3</sup>(4) In this section “the information Acts” means this Act and the Freedom of Information Act 2000.]
