An Act to make provision for preventing crime and disorder; to create certain racially-aggravated offences; to abolish the rebuttable presumption that a child is doli incapax and to make provision as to the effect of a child's failure to give evidence at his trial; to abolish the death penalty for treason and piracy; to make changes to the criminal justice system; to make further provision for dealing with offenders; to make further provision with respect to remands and committals for trial and the release and recall of prisoners; to amend Chapter I of Part II of the Crime (Sentences) Act 1997 and to repeal Chapter I of Part III of the Crime and Punishment (Scotland) Act 1997; to make amendments designed to facilitate, or otherwise desirable in connection with, the consolidation of certain enactments; and for connected purposes. Crime and disorder strategies

5 Authorities responsible for strategies. **E+W**

- (1) Subject to the provisions of this section, the functions conferred by [^{F20}or under] section 6 below shall be exercisable in relation to each local government area by the responsible authorities, that is to say—
- (a) the council for the area and, where the area is a district and the council is not a unitary authority, the council for the county which includes the district; [^{F21}and]
 - [^{F22}(aa) every provider of probation services operating within the area in pursuance of arrangements under section 3 of the Offender Management Act 2007 which provide for it to be a responsible authority under this section;]

 - (a) by cancelling any provision included in it; or
 - (b) by inserting in it (either in addition to or in substitution for any of its provisions) any provision that could have been included in the order if the court had then had power to make it and were exercising the power.
- (5) Where an application under subsection (4) above for the discharge of a child safety order is dismissed, no further application for its discharge shall be made under that subsection by any person except with the consent of the court which made the order.
- (6) Where a child safety order is in force and it is proved to the satisfaction of the court which made it ^{F104} ..., on the application of the responsible officer, that the child has failed to comply with any requirement included in the order, the court—
 - (a) ^{F105}
 - (b) may make an order varying the order—

- (1) A magistrates' court may make an order under this section (a "parental compensation order") if on the application of a local authority it is satisfied, on the civil standard of proof—
 - (a) that the condition mentioned in subsection (2) below is fulfilled with respect to a child under the age of 10; and
 - (b) that it would be desirable to make the order in the interests of preventing a repetition of the behaviour in question.
- (2) The condition is that the child has taken, or caused loss of or damage to, property in the course of—
 - (a) committing an act which, if he had been aged 10 or over, would have constituted an offence; or
 - (b) acting in a manner that caused or was likely to cause harassment, alarm or distress to one or more persons not of the same household as himself.

- (1) There shall be a body corporate to be known as the Youth Justice Board for England and Wales (“the Board”).
- (2) The Board shall not be regarded as the servant or agent of the Crown or as enjoying any status, immunity or privilege of the Crown; and the Board’s property shall not be regarded as property of, or held on behalf of, the Crown.

51B Notices in serious or complex fraud cases **E+W**

Sexual or violent offenders

86 Extended sentences for sex and violent offenders. **S**

(1) After section 210 of the 1995 Act there shall be inserted the following section—

“210A Extended sentences for sex and violent offenders.

- (1) Where a person is convicted on indictment of a sexual or violent offence, the court may, if it—
 - (a) intends, in relation to—
 - (i) a sexual offence, to pass a determinate sentence of imprisonment; or
 - (ii) a violent offence, to pass such a sentence for a term of four years or more; and
 - (b) considers that the period (if any) for which the offender would, apart from this section, be subject to a licence would not be adequate for the purpose of protecting the public from serious harm from the offender, pass an extended sentence on the offender.
- (2) An extended sentence is a sentence of imprisonment which is the aggregate of—
 - (a) the term of imprisonment (“the custodial term”) which the court would have passed on the offender otherwise than by virtue of this section; and
 - (b) a further period (“the extension period”) for which the offender is to be subject to a licence and which is, subject to the provisions of this section, of such length as the court considers necessary for the purpose mentioned in subsection (1)(b) above.
- (3) The extension period shall not exceed, in the case of—
 - (a) a sexual offence, ten years; and
 - (b) a violent offence, five years.
- (4) A court shall, before passing an extended sentence, consider a report by a relevant officer of a local authority about the offender and his circumstances and, if the court thinks it necessary, hear that officer.

 - (ii) his dependency or propensity is such as requires and is susceptible to treatment; and
 - (iii) he is a suitable person to be subject to such an order.

RETENTION AND DISPOSAL OF PROPERTY SEIZED UNDER SECTION 54(2A) OF THIS ACT

Application

- 1 This schedule applies to property seized under section 54(2A) of this Act.

Retention

- 2 (1) Subject to sub-paragraph (2) below, property to which this Schedule applies may be retained for a period of twenty-eight days beginning with the day on which it was seized.
- (2) Where proceedings for an offence are instituted within the period specified in sub-paragraph (1) above against any person, the property may be retained for a period beginning on the day on which it was seized and ending on the day when—
- (a) the prosecutor certifies that the property is not, or is no longer, required as a production in criminal proceedings or for any purpose relating to such proceedings;
 - (b) the accused in such proceedings—
 - (i) is sentenced or otherwise dealt with for the offence; or
 - (ii) is acquitted of the offence; or
 - (c) the proceedings are expressly abandoned by the prosecutor or are deserted *simpliciter*.

Arrangements for custody of property

- 3 (1) Subject to the proviso to section 17(3)(b) of the ^{M68}Police (Scotland) Act 1967 (duty to comply with instructions received from prosecutor), the chief constable shall, in accordance with the provisions of this Schedule, make such arrangements as he considers appropriate for the care, custody, return or disposal of property to which this Schedule applies.

- (4) No condition relating to the payment of any charge shall be imposed by the chief constable on the owner or person having right of possession of the property where he is satisfied that that person did not know, and had no reason to suspect, that the property to which this Schedule applies was likely to be used in a manner which gave rise to its seizure.
- (5) This paragraph does not apply where the period of retention expires in such manner as is mentioned in paragraph 2(2)(b)(i) above and the court by which he was convicted has made a suspended forfeiture order or a restraint order in respect of the property to which this Schedule applies.

Power of justice to take depositions etc.

- 4 (1) Sub-paragraph (2) below applies where a justice of the peace . . . is satisfied that—
- (a) any person in England and Wales (“the witness”) is likely to be able to make on behalf of the prosecutor a written statement containing material evidence, or produce on behalf of the prosecutor a document or other exhibit likely to be material evidence, for the purposes of proceedings for an offence for which a person has been sent for trial under section 51 [^{F497}or 51A] of this Act by a magistrates’ court ^{F498}. . . ; and

Power of Crown Court to deal with summary offence

- 6 (1) This paragraph applies where a magistrates' court has sent a person for trial under section 51 [^{F505} or 51A] of this Act for offences which include a summary offence.

Disputed bail hearings

- 3 (1) This paragraph applies to a preliminary hearing at which the court is deciding whether to grant or continue bail if the making of the decision is disputed (including where the court is minded to refuse or revoke bail of its own motion).
- (2) The accused may not take part in the hearing through a live audio link.
- (3) A person (other than the accused) may not take part in the hearing through a live audio link unless—
- (a) that person's participation through the live audio link is only for the purpose of giving evidence at the hearing,
- (b) there are no suitable arrangements by means of which that person could give evidence through a live video link, and
- (c) the parties agree to that person giving evidence through a live audio link.
