



# National Minimum Wage Act 1998

## 1998 CHAPTER 39

### *Agricultural workers*

#### **47 Amendments relating to remuneration etc of agricultural workers.**

- (1) The following enactments, that is to say—
  - (a) [<sup>F1</sup>the <sup>M1</sup>Agricultural Wages Act 1948,]
  - (b) the <sup>M2</sup>Agricultural Wages (Scotland) Act 1949, and
  - (c) the <sup>M3</sup>Agricultural Wages (Regulation) (Northern Ireland) Order 1977,shall be amended in accordance with Schedule 2 to this Act.
- (2) The appropriate authority may by regulations amend—
  - (a) [<sup>F2</sup>the <sup>M4</sup>Agricultural Wages Act 1948;]
  - (b) the <sup>M5</sup>Agricultural Wages (Scotland) Act 1949;
  - (c) section 67 of the <sup>M6</sup>Agriculture Act 1967 (sick pay);
  - (d) [<sup>F3</sup>section 46 of the <sup>M7</sup>Agriculture (Miscellaneous Provisions) Act 1968 (further functions of agricultural wages committees); and]
  - (e) the <sup>M8</sup>Agricultural Wages (Regulation) (Northern Ireland) Order 1977.
- (3) The amendments that may be made under subsection (2) above are any amendments which are consequential on this Act or on regulations under section 1(4), 2 or 3 above.
- (4) The appropriate authority may by regulations amend, or make provision in substitution for,—
  - (a) [<sup>F4</sup>section 7 of the <sup>M9</sup>Agricultural Wages Act 1948 (reckoning of benefits and advantages as payment of wages);]
  - (b) section 7 of the <sup>M10</sup>Agricultural Wages (Scotland) Act 1949 [<sup>F5</sup>(similar provision for Scotland)]; or
  - (c) Article 4(3) and (5) of the <sup>M11</sup>Agricultural Wages (Regulation) (Northern Ireland) Order 1977.
- (5) Subsection (1) above is without prejudice to subsections (2) to (4) above.
- (6) In this section “the appropriate authority” means—
