Membership of the Commission

- 2 (1) The Commission is to consist of—
- ^{F1}(a)
 - (b) members appointed by the Secretary of State to form a panel for the purposes of the Commission's general functions;
 - (c) [^{F2} members appointed (in accordance with paragraph 15(5)) from][^{F2}the members of] the panel maintained under paragraph 22;
 - (d) members appointed by the Secretary of State under or by virtue of—

 - [^{F4}(ii) section 104 of the Utilities Act 2000; .]
 - ^{F5}(iii)
 - (iv) Article 15(9) of the ^{M1}Electricity (Northern Ireland) Order 1992.

- [^{F7}(1A) A person may not be, at the same time, a member of the Commission and a member of the Tribunal.]
