# Power to extend or disapply [F23: Secretary of State].

- (1) The Secretary of State may by order provide that any of the authorities and bodies mentioned in subsection (2) is a best value authority for the purposes of this Part.
- (2) The authorities and bodies are—

  - (b) a levying body within the meaning of section 74(1) of the M1Local Government Finance Act 1988 [F25 in respect of which the county council or charging authority referred to in section 74(1)(b) of that Act was a council or authority for an area in England];
  - (c) a body to which section 75 of that Act applies (special levies) [F26 and which as regards the financial year beginning in 1989 had power to levy a rate by reference to property in England].

(4) The Secretary of State may by order provide for the Greater London Authority to be a best value authority for the purposes of this Part in relation to—

# 3 The general duty.

- (1) A best value authority must make arrangements to secure continuous improvement in the way in which its functions are exercised, having regard to a combination of economy, efficiency and effectiveness.
- (2) For the purpose of deciding how to fulfil the duty arising under subsection (1) an authority must consult—
  - (a) representatives of persons liable to pay any tax, precept or levy to or in respect of the authority,
  - (b) representatives of persons liable to pay non-domestic rates in respect of any area within which the authority carries out functions,
  - (c) representatives of persons who use or are likely to use services provided by the authority, and
  - (d) representatives of persons appearing to the authority to have an interest in any area within which the authority carries out functions.
- (3) For the purposes of subsection (2) "representatives" in relation to a group of persons means persons who appear to the authority to be representative of that group.

# [F343A Involvement of local representatives

- (1) Where a best value authority considers it appropriate for representatives of local persons (or of local persons of a particular description) to be involved in the exercise of any of its functions by being—
  - (a) provided with information about the exercise of the function,
  - (b) consulted about the exercise of the function, or
  - (c) involved in another way,

it must take such steps as it considers appropriate to secure that such representatives are involved in the exercise of the function in that way.

- (2) Subsection (1) does not require an authority to take a step—
  - (a) if the authority does not have power to take the step under another enactment or a rule of law; or
  - (b) if the step would be incompatible with a Community obligation or any other duty imposed on the authority under another enactment or a rule of law.
- (3) Subsection (1) does not apply—
  - (a) to a police authority,
  - F35(b) .....
    - (c) to any other authority or description of authority specified in an order made by the Secretary of State, or
    - (d) in any other case specified in such an order.
- (4) An order under subsection (3)(d) may specify cases by reference, in particular, to the following—
  - (a) best value authorities or descriptions of best value authority;
  - (b) functions of best value authorities;
  - (c) descriptions of local person;
  - (d) ways in which representatives may be involved in the exercise of functions of an authority.
- (5) In deciding how to fulfil its duties under subsection (1), an authority must have regard to any guidance issued by the Secretary of State.
- (6) In this section—

"enactment" includes subordinate legislation (within the meaning of section 21 of the Interpretation Act 1978);

"local person" means, in relation to a function of a best value authority, a person who is likely to be affected by, or interested in, the exercise of the function;

"representative" means, in relation to local persons or a description of local person, a person who appears to the best value authority to be representative of the local persons.]





# Best value inspections

# 10 Inspections.

- [F46(A1) The Audit Commission may carry out an inspection of a best value authority's performance of its functions or of any particular function or functions.]
  - (1) The Audit Commission may [F47, in particular,] carry out an inspection of a best value authority's compliance with the requirements of this Part.
  - (2) If the Secretary of State directs the Commission to carry out an inspection of a specified best value authority's compliance with the requirements of this Part in relation to specified functions, the Commission shall comply with the direction.
  - (3) Before giving a direction under subsection (2) the Secretary of State shall consult the Commission.

# 11 Inspectors' powers and duties.

- (1) An inspector has a right of access at all reasonable times—
  - (a) to any premises of the best value authority concerned, and
