131FB. Entry of premises under warrant

(1) A justice of the peace may issue a warrant under this section if satisfied on information on oath given by or on behalf of the [^{F3}FCA] that there are reasonable grounds for believing that the conditions in subsection (2) are satisfied.

- (5) If the statement differs from the draft published under subsection (1) in a way which is, in the opinion of the [^{F3}FCA], significant, the [^{F3}FCA] must (in addition to complying with subsection (4)) publish details of the difference.
- (6) The [^{F3}FCA] may charge a reasonable fee for providing a person with a copy of a draft published under subsection (1).
- (7) This section also applies to a proposal to alter or replace a statement.]

- (1) If a relevant person ("A") fails to comply with a requirement imposed on A under section 131E or 131F the [^{F3}FCA] may certify that fact in writing to the court.
- (2) If the court is satisfied that A failed without reasonable excuse to comply with the requirement, it may deal with A (and where A is a body corporate, any director or officer) as if A (or as the case may be the director or officer) were in contempt; and "officer", in relation to a limited liability partnership, means a member of the limited liability partnership.
- (3) A relevant person ("B") who, in purported compliance with a requirement imposed on B under section 131E or 131F—

- (a) provides information which B knows to be false or misleading in a material particular, or
- (b) recklessly provides information which is false or misleading in a material particular,

is guilty of an offence.

- (4) A person guilty of an offence under subsection (3) is liable—
 - (a) on summary conviction, to imprisonment for a term not exceeding three months or a fine not exceeding the statutory maximum, or both;
 - (b) on conviction on indictment, to imprisonment for a term not exceeding two years or a fine, or both.
- (5) Any person who intentionally obstructs the exercise of any rights conferred by a warrant under section 131FB is guilty of an offence and liable on summary conviction to imprisonment for a term not exceeding three months or a fine not exceeding level 5 on the standard scale, or both.
- (6) In relation to any contravention by a person, the $[^{F3}FCA]$ may not exercise both—
 - (a) its powers under section 131G(2), and
 - (b) its powers under subsection (1).
