#### COMMONHOLD

##### *Miscellaneous*

#### 62 Advice [<sup>F1</sup>etc.]

- (1) The [<sup>F2</sup>Secretary of State] may give financial assistance to a person in relation to the provision by that person of [<sup>F3</sup>information, training or] general advice [<sup>F4</sup> about, or a dispute resolution service in connection with—
  - (a) any] aspect of the law of commonhold land, so far as relating to residential matters [<sup>F5</sup>, or
  - (b) any other matter relating to commonhold land and residential matters].
- (2) Financial assistance under this section may be given in such form and on such terms as the [<sup>F6</sup>Secretary of State] thinks appropriate.
- (3) The terms may, in particular, require repayment in specified circumstances.
