[^{F1}Sexual exploitation of children]

50 Arranging or facilitating [^{F1}sexual exploitation of a child]

[^{F2}(1) A person (A) commits an offence if—

- (a) he intentionally arranges or facilitates the [^{F3}sexual exploitation] in any part of the world of another person (B), and
- (b) either-
 - (i) B is under 18, and A does not reasonably believe that B is 18 or over, or
 - (ii) B is under 13.

(2) A person guilty of an offence under this section is liable—

- (a) on summary conviction, to imprisonment for a term not exceeding 6 months or a fine not exceeding the statutory maximum or both;
- (b) on conviction on indictment, to imprisonment for a term not exceeding 14 years.]
