Local Safeguarding Children Boards

33 Funding of LSCBs in Wales

- (1) Any person or body specified in subsection (3) may make payments towards expenditure incurred by, or for purposes connected with, a Local Safeguarding Children Board established under section 31—
 - (a) by making the payments directly; or
 - (b) by contributing to a fund out of which the payments may be made.
- (2) Any person or body specified in subsection (3) may provide staff, goods, services, accommodation or other resources for purposes connected with a Local Safeguarding Children Board established under section 31.
- (3) The persons and bodies referred to in subsections (1) and (2) are—
 - (a) the [^{F1}local authority] in Wales by which the Board is established;
 - (b) any person who is a Board partner of the authority under section 31(3)(a) to (e);
 - (c) in a case where the governor of a secure training centre or prison [^{F2}or the principal of a [^{F3}directly managed] secure college] is a Board partner of the authority, the Secretary of State; and
 - (d) in a case where the director of a contracted out secure training centre or prison [^{F4}or the principal of a contracted-out secure college] is a Board partner of the authority, the contractor.
