(2) A local social services authority which provides premises, furniture or equipmen

- (b) any of the bodies established under this Act, or
- [F2(c) a local authority (as defined in section 579(1) of the Education Act 1996) for the purposes of the exercise of any education functions (as defined in that section).]
- (3) The permission may be on such terms (including terms with respect to the services of any staff employed by the authority giving permission) as may be agreed.
- (4) A local social services authority may provide (or improve or furnish) residential accommodation for officers—
  - (a) employed by it for the purposes of any of its functions as a local social services authority, <sup>F3</sup>...
  - <sup>r3</sup>(b) .....
- (5) In this section <sup>F4</sup>... "equipment" includes any machinery, apparatus or appliance, whether fixed or not, and any vehicle.
