Local social services authorities

192 Local social service authorities

- ^{F1}(1)
- (2) A local social services authority which provides premises, furniture or equipment for any of the purposes of this Act may permit the use of the premises, furniture or equipment by—
- (a) any other local social services authority,
 - (b) any of the bodies established under this Act, or
 - ^{F2}(c) a local authority (as defined in section 579(1) of the Education Act 1996) for the purposes of the exercise of any education functions (as defined in that section).]
- (3) The permission may be on such terms (including terms with respect to the services of any staff employed by the authority giving permission) as may be agreed.
- (4) A local social services authority may provide (or improve or furnish) residential accommodation for officers—
- (a) employed by it for the purposes of any of its functions as a local social services authority, ^{F3}...
 - ^{F3}(b)
- (5) In this section ^{F4}... “equipment” includes any machinery, apparatus or appliance, whether fixed or not, and any vehicle.
