1285 Extension of GB enactments relating to [^{F1}UK Societas]

- (1) The enactments in force in Great Britain relating to [^{F2}UK Societas] extend to Northern Ireland.
- (2) The following enactments shall cease to have effect accordingly—
 - (a) the European Public Limited-Liability Company Regulations (Northern Ireland) 2004 (SR 2004/417), and
 - (b) the European Public Limited-Liability Company (Fees) Regulations (Northern Ireland) 2004 (SR 2004/418).
- [^{F3}(3) In this section "UK Societas" means a United Kingdom Societas within the meaning of Council Regulation 2157/2001/EC of 8 October 2001 on the Statute for a European Company.]
