##### *Time limits*

- 5 (1) A reference must specify a period within which the <sup>F1</sup>CMA] must make a report on the reference.
- (2) A period specified for the purposes of sub-paragraph (1) must not be longer than six months beginning with the date of the reference.
- (3) A report of the <sup>F2</sup>CMA] on a reference does not have effect (and no action may be taken in relation to it under paragraph 7) unless the report is made before the end of—
- (a) the period specified in the reference, or
  - (b) such further period as is allowed under sub-paragraph (4).
- (4) Monitor may, if it receives representations on the subject from the <sup>F3</sup>CMA] and is satisfied that there are special reasons why the report cannot be made within the period specified in the reference, extend the period by no more than six months.
- (5) But Monitor may not make more than one extension under sub-paragraph (4) in relation to the same reference.
- (6) Where Monitor makes an extension under sub-paragraph (4), it must send notice of the extension to the relevant persons.
- (7) Monitor must also publish the notice.
