Transport

25 Disclosure of data relating to drivers' cards for tachographs

- (1) The Secretary of State may disclose data from the GB electronic register in accordance with—
- (a) Article 13(2) of [^{F1}Section 2 of Part C of Annex 31] to the Trade and Cooperation Agreement (interconnection and accessibility of electronic registers of data relating to drivers' cards for tachographs), or
 - (b) Article 13(4) of [^{F2}Section 2 of Part C of Annex 31] to the Trade and Cooperation Agreement (access for control officers to electronic registers of data relating to drivers' cards for tachographs).
- (2) The Department for Infrastructure may disclose data from the NI electronic register in accordance with—
- (a) Article 13(2) of [^{F3}Section 2 of Part C of Annex 31] to the Trade and Cooperation Agreement (interconnection and accessibility of electronic registers of data relating to drivers' cards for tachographs), or
 - (b) Article 13(4) of [^{F4}Section 2 of Part C of Annex 31] to the Trade and Cooperation Agreement (access for control officers to electronic registers of data relating to drivers' cards for tachographs).
- (3) A disclosure under this section does not breach—
- (a) any obligation of confidence owed by the Secretary of State or the Department for Infrastructure, or
 - (b) any other restriction on the disclosure of data (however imposed).

- (4) Nothing in this section authorises the making of a disclosure which contravenes the data protection legislation (save that the power conferred by this section is to be taken into account in determining whether any disclosure contravenes that legislation).
- (5) Nothing in this section limits the circumstances in which data may be disclosed under any other enactment or rule of law.
- (6) In this section—

“GB electronic register” means any electronic register maintained by the Secretary of State in accordance with Article 13(1) of [F5Section 2 of Part C of Annex 31] to the Trade and Cooperation Agreement (maintenance of electronic registers of data relating to drivers' cards for tachographs);

“NI electronic register” means any electronic register maintained by the Department for Infrastructure in accordance with Article 13(1) of [F5Section 2 of Part C of Annex 31] to the Trade and Cooperation Agreement (maintenance of electronic registers of data relating to drivers' cards for tachographs).
