LIABILITY: OFFICERS AND OFFICES: FEES

9 Fees charged by public trustee.

- (1) There shall be charged in respect of the duties of the public trustee such fees, whether by way of percentage or otherwise, [^{F1}as the Lord Chancellor may fix.].
- (2) Any expenses which might be retained or paid out of the trust property if the public trustee were a private trustee shall be so retained or paid, and the fees shall be retained or paid in the like manner as and in addition to such expenses.
- (3) Such fees shall ^{F2} . . . be applied as an appropriation in aid of moneys provided by Parliament for expenses under this Act, and so far as not so applied shall be paid into the Exchequer.

- (5) The incidence of [^{F4}any expenses retained or paid] under this section as between capital and income shall be determined by the public trustee.
