PART I

REGISTRATION OF BIRTHS

1 Particulars of births to be registered.

- (1) Subject to the provisions of this Part of this Act, the birth of every child born in England and Wales shall be registered by the registrar of births and deaths for the subdistrict in which the child was born by entering in a register kept for that sub-district such particulars concerning the birth as may be prescribed; and different registers shall be kept and different particulars may be prescribed for live-births and still-births respectively:
 - Provided that, where a [FI still-born child] is found exposed and no information as to the place of birth is available, the birth shall be registered by the registrar of births and deaths for the sub-district in which the child is found.
- (2) The following persons shall be qualified to give information concerning a birth, that is to say—

2 Information concerning birth to be given to registrar within forty-two days.

In the case of every birth it shall be the duty—

- (a) of the father and mother of the child; and
- (b) in the case of the death or inability of the father and mother, of each other qualified informant,

to give to the registrar, before the expiration of a period of forty—two days from the date of the birth, information of the particulars required to be registered concerning the birth, and in the presence of the registrar to sign the register:

Provided that—

- (i) the giving of information and the signing of the register by any one qualified informant shall act as a discharge of any duty under this section of every other qualified informant;
- (ii) this section shall cease to apply if, before the expiration of the said period and before the birth has been registered, an inquest is held at which the child is found to have been still—born.

Information concerning finding of new-born child to be given to registrar within forty-two days.

Where any [F3 still-born child] is found exposed, it shall be the duty of the person finding the child, . . . F4 to give to the best of his knowledge and belief to the registrar, before the expiration of forty—two days from the date on which the child was found, such information of the particulars required to be registered concerning the birth of the child as the informant possesses, and in the presence of the registrar to sign the register:

- (1) Where the place and date of birth of a child who was abandoned are unknown to, and cannot be ascertained by, the person who has charge of the child, that person may apply to the Registrar General for the child's birth to be registered under this section.
- (2) On an application under this section the Registrar General shall enter in a register maintained at the General Register Office—
 - (a) as the child's place of birth, if the child was found by the applicant or by any person from whom (directly or indirectly) the applicant took charge of the child, the registration district and sub-district where the child was found, or, in any other case, where the child was abandoned;
 - (b) as the child's date of birth, the date which, having regard to such evidence as is produced to him, appears to him to be the most likely date of birth of the child, and
 - (c) such other particulars as may be prescribed.

4 Registrar's power to require information concerning birth.

Where, after the expiration of forty—two days from the date of the birth of any child or from the date when any [F7still—born child] is found exposed, the birth of the child has, owing to the default of the persons required to give information concerning it, not been registered, the registrar may by notice in writing require any qualified informant—

11 Special provision as to registration of still-birth.

- (1) Any qualified informant giving information to the registrar of the particulars required to be registered concerning a still-birth shall upon giving that information either—
 - [F28] deliver to the registrar a certificate in the prescribed form signed by a registered medical practitioner who was present at the birth or has examined the body of the child, or, if no registered medical practitioner was so present or has examined the body, by a [F29] registered midwife] who was so present or has examined the body, being a certificate stating that the child was not born alive and, where possible, stating to the best of the knowledge and belief of the person signing it the cause of death and the estimated duration of the pregnancy; or
 - (b) make a declaration in the prescribed form to the effect that no registered medical practitioner or [F29 registered midwife] was present at the birth or has examined the body, or that his or her certificate cannot be obtained, and that the child was not born alive.

14 Re–registration of births of legitimated persons.

(1) Where, in the case of any person whose birth has been registered in England or Wales, evidence is produced to the Registrar General which appears to him to be satisfactory that that person has become a legitimated person . . . F38 the Registrar General may authorise at any time the re–registration of that person's birth, and the re–registration shall be effected in such manner and at such place as may be prescribed:

Provided that, except where—

15 Particulars of deaths to be registered.

Subject to the provisions of this Part of this Act, the death of every person dying in England or Wales and the cause thereof shall be registered by the registrar of births

Registers, certified copies, etc.

25 Provision of registers, etc., by Registrar General.

Registers of live-births, still-births and deaths shall be in such form as may be respectively prescribed, and the Registrar General shall provide any such registers, and any of the forms hereafter mentioned for making certified copies of entries in registers, which may be required for the purposes of this Act.

Quarterly returns to be made by registrar to superintendent registrar.

- (1) Every registrar shall in the months of January, April, July and October on such days as may be appointed by the Registrar General—
 - (a) make and deliver to the superintendent registrar in the prescribed form a true copy, certified by him in the prescribed manner, of all the entries of live—births, still—births and deaths made in the registers kept by him during the period of three months ending with the last day of the month immediately preceding that in which the copy is required by this subsection to be made;

Any notice, information, declaration, certificate, requisition, return or other document required by or under this Act may be sent by post.

41 Interpretation.

In this Act, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them, that is to say—

"birth" includes a live-birth and a still-birth;

"disposal", in relation to a dead body, means disposal by burial, cremation or any other means, and cognate expressions shall be construed accordingly;
